AGENCY COMMENTS

1. Has current agency personnel worked with this firm recently? Is there an active contract in place? Yes, CGL is currently working with DCAMM on two active contracts for projects with the Trial Court: the Quincy Trial Court and Brockton Superior Court and Trial Court Building Modernizations. In those projects, CGL acts as a consultant (Courts Strategic Planner) supporting the Prime Architects, Schwartz Silver and Ann Beha Architects, respectively. CGL's approach to correctional projects is different than their current courthouse projects with DCAMM; they have been the Prime Architect in correctional projects in other parts of the country and have deep expertise on that and different staff that work on those projects. 2. Was the application responsive to the evaluation criteria found in the public notice? CGL prepared a useful narrative under Section 5 Supplemental Response to Evaluation Criteria, including strategy teaming, project approach and project experience, but did not respond to the four evaluation factors listed in the DSB ad. 3. Based on the likely scope of work and the affirmative marketing requirements indicated in the public notice, does the agency have any concerns regarding the design team's ability to meet these goals? No, DCAMM has no concerns as the team includes four firms with DBE designation. 4. Please provide any other comments, concerns, or issues you have with the team. The Prime Architect team includes one correctional planner and two correctional designers in addition to Project Director: all with extensive experience in corrections. Dewberry's team involves many disciplines, including C-M-E-P-FP Engineers and Security consultants. Dewberry's team also include a Director of Justice Architecture, a Detention Facility Planner/Designer, and a Corrections Project Architect, although their interaction with the Prime Architect's correctional planner and correctional are not clearly explained. The proposal does mention that "CGL will work with Dewberry to determine the appropriate staff to handle project needs" but it would've been helpful to know their approach for coordinating the work of planners and architects between the two firms.
