Good morning, Everyone,

Just wanted to check in with you all. The community transmission level for COVID in our area is still high: https://www. dupagehealth.org/610/DuPage-County-COVID-19-Dashboard. As a result, we will be requiring masks for all patrons and staff throughout the entire building regardless of vaccination status.

Yesterday, Allyson put up the new signage at both entrances and throughout the building; Cindy ensured our messaging was updated on the website and social media.

Remember: any patrons who refuse to wear masks in the building will be refused service. This includes: one-on-one help, reference interactions, public computer use, study room reservations, video gaming, assistance with checking out, escorting patrons to the stacks, etc. If patrons want our assistance, they will need to wear a mask. Masks are required for in-person **service**. If patrons forget a mask, please offer one. Masks are available at all service desks.
