I hope that you are all enjoying your weekend. Two things.

1. Given that this is the July 4<sup>th</sup> week – I am going to cancel our call tomorrow Monday June 29<sup>th</sup>. We are all off on Friday – so there will be NO 9 am calls this week. We will resume with our 9 am calls on July 6<sup>th</sup> (Monday).
2. There was a joint order that answered Marie's question regarding staff that knowingly travels from June 25<sup>th</sup> onward to states that have high covid rates. Employers may charge those employees with sick time during quarantine.
