that that is one of the concerns of the school district is how other parents would react. So thank you for 100% documenting and verifying the gas lighting techniques the school district has employed against me for 5 years that have caused my health conditions to suffer greatly.

Do you once an opportunity to correct that mistake and accusing me of making presumptions when it is a factual statement made by a school district representative? Just like you accusing me of having been convicted of a crime against a child when I have no such crime on my record and that is in school district possession.

I would like to also inform the school district that I have now been informed by an education lawyer that as of 2017 when my dismissed conviction no longer appeared on my record the school district was not and is not allowed to consider it or reference it as was inappropriately done in the punitive actions done recently against me in court to prevent me from exercising my due process rights.
