This letter is both an initial acknowledgement and final response to your request for public records referenced in your October 27, 2021 emails, which we numbered for easier reference:


Item 1: *"So I would like a public records request for any offers made by the district to alleviate my fears that do not include meeting on district property or having to directly deal with principal Stewart."*

I wanted to follow up with you regarding the questions you have regarding Lillian being injured at recess. You asked how many adults supervise recess and how many children they supervise. We have a minimum of two staff members on duty at each recess. In addition, whenever possible there is a third staff member on duty as well. There may be times that volunteers are on the playground but we do not rely on them as part of our supervision plan.

At primary recess we have around 200 students. You asked why the adults had to be told by students that Lillian was hurt. Our recess supervisors are actively monitoring and assisting students. Due to the active nature of recess students are continually moving. They cannot have their eyes on each individual student at every moment. They are however constantly scanning and monitoring. As part of our work around school climate, we are always talking with students about helping one another. Students know that if someone gets hurt they go get adult help.

In terms of a list of approved volunteers, there is not a list that we release to families. We also do not share who has and has not been approved with anyone other than staff. If you have concerns about specific individuals and their safety around our students, then I invite you to let me know your concerns and I will address them accordingly.

I have taken the morning to try and sort my thoughts on your statement of "approved background check". My background check met the school standards and I need to say that. What was not met was me being an "exemplary adult" as Ms. Phillips put it. Mr. Irish admitted it was a "discretionary" choice in reference to the murder conviction with you present, Ms. McDuffy in email has stated she cant "grant a waiver" after a meeting discussing the "discretionary" choice by Mr. Irish and yourself, and finally Ms. Phillips ignored the murder charge and admits that from yourself up to and including her the decision to go off of "feeling" the lower charge was serious enough that I was being denied "even though its not on the schools list". So please lets be honest I didn't fail as it is well documented on the "discretionary" choices, the inability (unwillingness) to "grant a waiver", and finally the

"feelings" as opposed to following established school protocol and procedure is what keeps me from being a volunteer. That is why I was not approved...in short you and your superiors have chosen not to like me as a human being and tell my daughter that I am not good enough. All of this because for some reason with me the only items considered are the negatives lies told by the prosecutors office that you all have in black and white yet choose to alienate and cause harm in my relationship with my daughter. Even law enforcement personnel I am acquainted with are encouraging me to keep fighting. It is well documented at this point that The Edmonds School Board, Superintendent, Assistant Superintendent, and yourself operate on a system of double standards and secrecy.

I cant even look up school policies and have trust that they are accurate due to you telling me they are not current and that **by next summer they will be updated**. Any bets on a new crime be added to the list of things that keep a parent out? How is a parent supposed to have any faith in the honesty and integrity of you folks. I believe I know the answer because I am somehow getting all the crap that no one else gets? Other parents are astounded at what I am dealing with.

What grates me the most is that you say you are sorry and I just don't believe it. Of all the things you could have said those words over they were never used until it was way too late and in my opinion you lied to me twice in person and allowed your chain of command to be completely dishonest with me. Believing for some reason I would not find out. I am physically ill everyday from Lillian being in Brier Elementary. In the end you folks have taught me there will never be any understanding or forgiveness in my life by anyone who has an official role that gets a pay check from tax dollars. Funny I never did anything other than out of fear for my safety and my families and didn't break any laws, yet because a public servant wanted to cover up their lies and mistakes here we are. Kind of Ironic that Public officials can be dishonest, cover up the truth of their own actions, hide information from the public and then deny and or punish a member of the public for asking questions and or standing up for themselves.

I know in the end it is 100% personal from you folks to me as every single professional I have spoken to is simply blown away by the fact that I offered to pay for an chaperone, classes, or courses to be deemed acceptable and that I brought up events more recent then what you folks judge me by and those issues to this day have never even been acknowledge by you folks on any level. If this was professional and done with standards then some sort of course could have been set. I am not dealing with fair nor open minded and inclusive individuals. What I have encountered is the complete opposite at every point since the second time of meeting Ms. Yampol and the first time of meeting you. After your staff broke school policy that you personally assured me would **NEVER** happen and it has actually happened twice now. No reprimands of any nature and continued breaking of stated school policies and I am punished for speaking up.

I truly am trying to let it go but it is insulting on every level to know that volunteers are being begged for and simply because you guys don't like me as a person you wont let me. I pose zero threat as has been established and have followed every rule set forth for me even when it abused my daughter and you folks say I can't be trusted. It turns my stomach daily.

These are the only things I hope to get an answers on (though I doubt I will) out of all of this and it relates to Lillian's injury. You said "other children notified" the adult on the playground that Lillian was hurt and they turned and saw her sitting in the hula hoop crying? What was going on that the adult in charge had to be notified by children that another child was hurt? Where was their attention and are were they a parent volunteer or school staff member? How many adults are there to supervise how many children? Lastly is there a list of approved parent volunteers or am I allowed to ask if certain people have been approved as volunteers if I have questions about specific individuals?

Happy Easter to all of you,

I am alone today and the only thing I have to do is try to process everything and understand. I just can't get through it. You won't even acknowledge that the prosecutor WAS CAUGHT USING LIES AGAINST ME. That is what the entire story you read was in the paperwork. The prosecutor's lies. That was the story they told to get the convictions

against me and I simply couldn't prove it on the first charge. I have been dealing with judgment from people like you for 20 plus years and never thought for one moment that it would hurt my daughter the way it is. I was diagnosed with PTSD from everything I have dealt with in life. I was arrested trying to report for military duty and that is where I learned just how vicious and cruel people with titles and power can be. Please before you say another reason to not allow me around the children know that the way it comes out in me is with words and statements such as I have done with you folks. I have never once had a physical issue with or because of the PTSD. Just like when I walked away from Mr. Irish and principal Stewart to control the emotions.

Principal Stewart, you had your mind made up about me before I ever applied. Before school ever started Ms. Yampol broke school policy you personally assured me would never be broken. Remember sharing information between the two homes that cause Angela to threaten me with losing a day of visitation. What was the recourse by you? To assure me it would never happen again and it didn't with Ms. Yampol but another staff did as I mentioned before. Then the first time we meet in person and I introduced myself and LILLIAN to you. You responded by telling me you have already met her as Lilly and asked if it was ok to call her that. I responded and said her name is Lillian to which you responded "I will ask her what she wants to be called and that's what we will call her". I ended up in email explaining the name situation for LILLIAN to you. Yet when I am not around you still choose to call her Lilly which shows you have zero regard for what I share concerning my daughter. You are helping to reinforce with her that people don't care about her feelings. At this point she also has quit caring but she tells me she still wants me to tell people. She is 6 and you have helped her learn to not stand up for herself. Thank you.

After that when I applied you told me you would point out I was upfront, honest, and open about everything and didn't try to hide anything including bringing in the paperwork for you. You know the paperwork where the Appellate Court Justices point out the prosecutor used LIES. I did not kill anyone and I did not know anyone was going to get killed. Again if I had the money I could have fought to completely clear my name just as if I had the money I could get you the evidence. The prosecutor only arrested me after I refused to tell their lies. If you don't believe they would do that then you are refusing what the appellate court judges said. The prosecutor uses lies. Ms. Phillip's said my assertions can't be believed but she and you will believe the "assertions" of the only people the courts said lied? I point all of this out because no where have I seen where you told your bosses the thing you said you were going to. This is why I want everything documented and recorded between us. I dealt with the courts, the child advocate, and now you and your bosses. All with titles and almost all do differently then they say they will. For a little background feel free to look up Cynthia Bemis on king 5 news. That is one professional I have had to deal with and trust me it is about to become a big issue for Snohomish County by people other than myself. Included in that is my situation and everything I have had to deal with for 20 years due to corruption, lies, and dishonesty by professionals.

You told me you would tell your bosses these things as this was a decision you couldn't make because of how unique it is. You had to get your bosses input. You ultimately told me I was denied as a volunteer and I sought out your boss. We scheduled a meeting with Mr. Irish that lasted what, maybe a minute? Yes I got pissed and walked out. I came seeking a middle ground and was treated and a piece of shit stuck to the bottom of a worn out shoe by Mr. Irish and yourself. After that was when I came to have lunch for the first time and you changed it from not being a volunteer and only being allowed to do what all parents are allowed to do at anytime to not being a volunteer and only being on campus to pick Lillian up and drop her off. What is it that you have to hide that parents are not allowed open observation of their children in classes? Are you hiding more Leif Otterholts? That is my

fear every day is what are you hiding from me because you know beyond doubt I will speak up. When you told me I could not have lunch with Lillian and she burst into tears when I was telling her I couldn't stay (notice I didn't even tell my daughter it was your fault when it was!!!) and that I had to go is when you offered to let me eat lunch in the enclosed private room in the office. That happened twice before my meeting with Ms. McDuffy which after two days yielded the results of still not volunteering but I was at that point allowed to eat lunch in the cafeteria? That is where the decision was made and until now no one claimed it was made by you and it was clearly made by Ms. McDuffy as she is the one who told me and not you.

There have been many unanswered questions since then. Why didn't you close down the iced over hill which caused a parent to lose control of their vehicle and smash through the light post on February 3rd I believe it was? That one situation put more children at greater risk than I ever have with anything and you don't resign (bosses why is she still in a position of authority to make that mistake again?) yet you tell me that a decision to try and protect lives from 20 years ago is worse? What is the status on Brier/Edmonds not telling parents about head injuries? Oh by the way the reason it was so confusing is no one actually listened to or asked Lillian what happened in my opinion. She got very confused after her head got hit (one of the signs of concussions and Post Concussion Syndrome as well) and it took her until that evening to be able to communicate completely her head hit the ground. She was confused because no one let her say what happened fully it seems. Everyone listened to the other children that she got hit in the head but that was it. You told me you would have your para call around to compare procedures and maybe make some changes. I also thought you said you would let me know but I have not heard a thing and obviously it is not a huge issue to you. Oh I know you claim you have school guidelines for everything but you sure are willing to go outside of them to deny me to be a volunteer. Funny you stand on them to defend your actions and say it is ok to ignore them when they don't let you do what you want? Again that is Discrimination.

What was the outcome of my abuse complaint by Ms. Yampol? I know you called Aston's father and said "Ms. Yampol was a little stern in her discipline today". She wasn't stern she was openly publicly threatening a child with emotional punishment and openly told the rest of his young peers he wasn't worth tolerating that day? You accept and excuse that child abuse? Bet if I did something like that you would call the cops and cps saying I was hurting my daughter emotionally in a New York Second.

What about the issue of Lillian and I almost being hit by a school bus. Never heard a thing on that other than you would tell the transportation department. I made a video the other day when parents were racing around cars that were stopped for the same bus coming in and there was almost an accident. I know you are aware of the issues on that exit and yet nothing gets done to change the safety for the kids? Another current decision yet a decision from 20 years ago stops me from being a volunteer? Of course that is only with the school and not with the PTA which means you don't truly feel I am a threat or dangerous. Either that or you value your career more than you truly believe I am a threat. If I thought someone was a threat to children my career wouldn't matter to me if I knew they were around children. Guess that is just another difference between us.

What about the crossing guard incident where the adult told a driver to go (driver did not take the right turn) like 6 times which would have injured my daughter, another child and adult as well. Any corrective actions there? Nope I already know that answer.

What about you and Ms. Yampol losing Lillian three times (you blaming Lillian for the second time) which ultimately now we know that Lillian following directions was not the issue on any of the occurrences. What has happened to Ms. Yampol for losing Lillian three times? Oh and I really enjoy how you told me the adults do not listen to the children about

where they are supposed to be in the beginning and yet you blamed Lillian and then told me that Lillian told your office staff that I was supposed to be picking her up? So much for not listening to the kids. Again current decisions placing a child at risk not made by me and that person still has their title and status while I am denied from an old decision? I mean heck you are willing to take steps to help Ms. Yampol so she can keep her position and wont do anything to help me be a volunteer? Sexist?

You claim the cafeteria/gym is a secured environment yet wont answer a basic question about my activities in said location. I also want to point out that I know of parents who think the sign in procedure is a joke as they openly walk past your office WITH YOU SITTING IN IT SINCE YOUR BACK IS TO THE WINDOW WHILE YOU DO COMPUTER WORK. Which is often considering the number of times I have seen you at your desk completely oblivious to what is going on right outside your office window. Kind of hard to see what is going on when your back is to the main window looking out isn't it? It is also interesting to note that it seems the only time you kick people out of the gym lobby is when I am present. I have had a number of other parents comment on being confused at when you will kick them out and when you wont. There is one parent in particular who has never been told to not be in there. Just like the day you say myself and a couple of other parents in there and walked right on by without saying a word. Complete lack of consistency in my opinion.

I have had many parents tell me they commonly forget to sign in and just go straight to class rooms and never have issues. Of course it has been all women to have told me this. In these conversations it has been expressed to me that Brier elementary while being great at education is a very hostile work environment and also is not the place to speak your mind or even speak up about issues and there will be reprisals. Can you guess who people are afraid of upsetting? I say this not to be mean but to point out that I don't make decisions typically without as much information as possible being collected first. You and Brier claim to be all inclusive and caring and I assure you for many people it feels anything but that. I am not the only one.

ONE of the issues between us is that to me it is very plainly obvious you chose not to like me from before school even started and that could only have occurred if you and my ex had spoken which you indicated you had already spoke to her when you met me. Of course you will say you are neutral and don't take sides but should I believe that like no information will be cross shared, you will tell your bosses how upfront and honest I was, that Lillian wont be lost a second or third time, that you didn't communicate with my ex about the first two times but she knew about the steps you took to prevent it again, that I can ask questions and they will be answered, or that your staff are held accountable for violating/breaking school policies and rules? Of course those policies and rules will be fully updated by then end of NEXT summer so who knows which ones are even accurate right?

I came in openly and honestly to avoid any issues and you and your bosses have done nothing but create them by ignoring me and abusing my daughter and I. Again why couldn't we have found a way through all of this as I initially asked and offered to do anything and was completely ignored. Only conclusion anyone can come up with is because this was not based on anything other than a personal dislike. I have wondered who it could have been but you finally owned it by claiming you made the choice to authorize me to eat lunch in the cafeteria. I think we have covered it was not you who did that but it at least shows that it for some reason is a personal issue that you have against me as a man standing up for my child's and my own rights in which you have been fully supported in your personal attack against me by your bosses. Though I don't believe they were fully aware. But hey ignorance is no excuse as you have shown me.

I decided to type this out since you asked me for a list of the questions that are

unanswered. This is a very small portion of the issues and no I am not willing to meet with you and Mr. Irish especially in an enclosed environment of any nature. I trust anyone one of you as much as I trust a prosecutor to tell the truth. Oh by the way the newspapers printed only what the prosecutor wanted. They never once printed the truth. FYI.

My unwillingness to meet privately with any of you is for my protection as you have repeatedly all changed your stories and statements to me which the majority of which are documented in email. There has been zero concern or care for my feelings, emotions, or opinions (even on Lillian's safety) this whole time. Principal Stewart, when you asked about ideas to keep Lillian from getting lost and I responded that do what ever you want because I have no say so anyways. Your response proved my point. It would have been a simple thing to say "No I want you as a parent to be comfortable and happy with the decision so please may I get your feedback?" but that is no where near what you did is it? You made the choice and showed you did not care about my opinion. Again showing it is a personal issue. I have been told by other parents how outgoing you are and how much effort you exert so why don't I get that same treatment? Discrimination much?

In my opinion you are all a bunch of cowards. You abuse my daughter and hide behind not answering questions that show the mistakes you have made and the biased judgment used against me. For a reference check the 30 or so questions Ms.McDuffy was going to have the law firm respond to that I withdrew out of fear of losing what I have. It is better for my daughter to learn I will fight for her no matter what the cost and by proxy what kind of people you folks are then to think I would ever quit on her.

Ms. McDuffy if that was the school law firm on retainer than why didn't you know that was who Mr. Irish spoke to about me? Because they weren't and he didn't and that is another example of the exemplary behavior by you folks. Did you catch that Ms. Phillips? You condone that as exemplary behavior?

I am asking to give my daughter happy and complete memories and experiences and that is what you are saying no to thereby depriving a child and hurting that child? Is not that child abuse? Oh I know you do it under the color of authority so it is ok.

Again Happy Easter to all of you and I hope that for those of you that have children you got to see them today. I don't even get to talk to my daughter because people like you folks make decisions like you do.

I have repeatedly now said I am not comfortable meeting with you and your response simply shows that my thoughts and feelings have no value. I will not tell you who the staff were because you chose not to give any discipline to Ms. Yampol for her actions on word parade day so I will not place other staff at jeopardy of your judgment. I again brought up being willing to work on a way through all of this and again have been ignored.

You have changed your story again here and now you did not approve me you told me I wasn't allowed on school property. Remember making Lillian cry. Your bosses approved me. The only question is why are you so unfair in your judgment of me. You claim exactly what Angela claims so it is a pretty easy guess as to why you are doing these things. I have zero willingness to meet with you again especially on school grounds as I have said I believe you have ill intent towards me. That is what you have shown me and the only thing I have experienced from you so why would I think anything else?

Yes the Superintendent is forcing me to communicate with someone I have openly stated I feel is a liar, a hypocrite, a child abuser and has ill intent. I apologize for the delay in responding. I believe the "first meeting" you are referring to is when I asked Lillian if she had a preference of being called Lilly or Lillian. My intention was not to disrespect you. My intention was to show Lillian respect and to give power to her voice. Please remember that I did not have any awareness of the history you later shared around your view of the name. When you shared your energy around the name, I started using only Lillian out of respect for your feelings.

In your statement "I doubt we will ever see eye to eye", the only thing I can perceive that you are referring to is your volunteer application. Mr. Dodgen, I sought District consultation and followed that consultation. I, as well as my supervisors, are responsible for doing our best to ensure the safety of the 456 students here at Brier Elementary as well as the rest of the students in the school district. We strive to have processes in place to help us with this task. Included in those processes are the background checks. I understand that you are disappointed and frustrated about the decision. Other than that topic, I am not sure what we disagree on. To the contrary, I believe we agree on a key topic- doing everything we can to support Lillian in being successful.

As I have mentioned before, there are many families for a variety of reasons who are unable to volunteer during the school day yet there are many other ways to be involved in school. You have been taking advantage of many of those including coming to have lunch, coming to open classroom events, and attending evening school events. If you have interest in seeing if there are projects you can do at home to volunteer, I invite you to reach out to the teacher. Supporting Lillian at home with reading to/with her as well as support with homework is also key.

I appreciate you naming that "Between life on the streets and life in prison I have seen far too much violence and heartache to ever choose to use it as a solution." I would appreciate it if you would refrain from standing outside my window and staring at me. It is awkward for people when they are meeting with me.

Mr. Dodgen, I respect your love for your daughter and I would like to find a way for you to feel valued here at school even though your application has been denied.

I did not commit a crime and the prosecutor knew that....I am sorry that my actions based in fear are so reprehensible to you and your colleagues. The week went exactly as I expected. Zero communication on why a convicted felon with a record essentially identical to mine was allowed to volunteer and have exposure to Lillian after I specifically left instructions for her safety that he not be allowed to have contact with her?

I was going to send the video I made of the meeting with Principal Stewart (Ms. Ebright as a "scribe") where principal Stewart says "you must have different information that I do" and "we follow a procedure for volunteers when forms are turned in". Unfortunately my phone was not prepared to record the full meeting but I did quote the background check rcw 43.43.830 to principal Stewart which garnered no response.

So Principal Stewart, why did you allow Kevin Hassett access to Lillian after I directly notified you he had felony drug convictions on his record and I did not want him to be around Lillian? If that required me removing her from school for her safety why didn't you tell me that? This part is on recording!

Now after that why didn't Mr. Irish or Mr. Erdman respond to a known felon being on campus?

After this comes the procedure you mentioned on video Principal Stewart? Is that the same procedure you "applied" to me? Mr. Hassett and I have nearly identical legal records including a dismissed felony and one felony that stands against us however, they don't appear on the list to be prevent us from volunteering.
