Happy New year to you all,

Since I have received the records during the winter break I chose to wait until it was officially over to ask my questions.

- 1) In the response for public records request question 4 pertained to school/road closures in the last four years as I understand that is how long Principal Stewart has been there. None are listed other than for 2016-2017 year (same year as the accident) with Dec 9th specifically citing icy roads and all three days listing snow. How can you close the school if you cant close the road? I might have to clarify this records request to get the year that isn't listed but I think these records are enough to show that it was known the authority was there making the answer I was given a complete fabrication? I still have not received the information to verify anything even though I asked 8 times at least? Or is this just going to end up like the 478 pages of redacted emails? Honest people have nothing to hide right?
- 2) Funny how I can specifically ask if the schools legal counsel is aware of how the courts actually work and you folks all want to hide and cover it up. Then you "claim to be afraid" because I demand answers and the truth? I know the truth and so do you all. The courts don't operate like you say you want and so you abuse my daughter and myself because of supporting my ex. Are you exemplary folks really going to refuse to answer and acknowledge that the court of appeals does not declare innocence as you claim they would need to for me? I have already sent the screen shot of Mr. Erdman actually saying they don't work that way and none of you want to respond? Why not? 478 pages?
- 3) I asked for records of any staff being held accountable for anything that has happened and no one has even been reprimanded at all it seems. DO NOT EVER ACUSE MY DAUGHTER OF BREAKING THE RULES! If you refuse to hold staff accountable you will not hold my daughter accountable for any accusation you level against her. I expect them to come since you have already implied she lies on at least two occasions or you are implying I am manipulating her. Either way if you don't follow the rules you can't hold her accountable for anything.
- 4) I was sent links to 9030 and 9030R1 I believe. not really sure as they don't work but Mr. Erdman confirmed in email that those are the policies that cover visiting for lunches and as I already sent Principal Stewart seems to have changed Brier policy on it. Back ground checks were never a part of District policy and the last time they were modified was in 1993 so how could any of you claim that Principal Stewart thought they were required? If she didn't know that policy what else does she not know. Oh that and not being able to close the main entrance to protect the children? Your answers for everything seem to be the staff didn't know. Just like I didn't know anyone was going to die. But I know Ms. Phillips my word isn't good enough for you.
- 5) Last year my daughter was bullied on her bus by a 6th grade boy. Mr. Erdman says he has determined nothing happened because the bus driver says so. Well there are no reports of anything on the bus with my daughter but guess what? I have an email from my ex stating that this year my daughter got hurt on the school bus so why is there no report of that? Seems reporting things may not be what the bus driver does. Just like when she gave religious instruction to my daughter and Principal Stewart still has never followed up with me on that. When I sent an email to my ex about the bullying she never responded which kind of shows she already knew about it. What kind of parent would not be concerned about their kindergarten age child getting bullied by a 6th grade boy to the point of tears? My ex never addressed the topic and things were handled with out any notice to me as Lillian's father. You cant claim there would have been a report because there is no report over my daughter being hurt on the bus let alone bullied. So you still expect me to think my daughter is safe under your peoples care?
- 6) Last item. #10 At the alleged appeal hearing where I was given about 15 minutes to address a 62 page rubber stamped report (done to cover up and protect you folks from the abuse you have given my daughter and myself) Dr. McDuffy chimed in and said she wanted to "remind the board that this appeal was about my volunteer status only". Mr. Mhyre was kind enough not to redact this information (total surprise to me) and as the records show I have never had an appeal on my volunteer status. I had an appeal on the finding of the four issues that were allegedly investigated by Mr. Bue. My volunteer status was not one of those issues. The reasoning behind it was. The reasoning behind it determined that you folks have gone off of more than the state patrol background check (though it is not worded that way) in your denial of me. Last I checked having different standards is discrimination. So was Dr. McDuffy simply confused about the hearing (as well as the rest of you) and did Mr. Erdman stay confused in the many times after where he reinforced in email that the hearing was ONLY about my volunteer status? Please show me any communication that clarifies that is what it was over? There is none. There is communication showing the appeal was about the results of the investigation which is what I came to address. Your final letter to me where you say you will not address these issues any further even states it was about my volunteer status and does not address any of the issues I

addressed appropriately at the hearing before being cut off. So now that your own records show it was in fact not about my volunteer status and was about the 4 issues of the investigation I believe it is very clear you all denied me due process even under your own policies.

Over winter break I was at the Alderwood mall with Lillian. As we were leaving she went to play in the grassy area and on the rocks as she normally does. As I was walking towards her a group of teenage boys suddenly surrounded two other boys and girl. One of the two boys was singled out and a gang style attack started to occur. Since my daughter was safe and away but I was essentially trapped by the situation I intervened while many "exemplary" people that I am sure you would approve to be a volunteer stood back and were allowing the attack to happen. When I yelled and stepped to block the young man being attacked one of the assailants turned and threatened me. I simply told him I would call the cops to which he laughed and said he would give me the phone number. He looked as though he considered attacking me but changed his mind and the gang/group of assailants quickly dispersed. Not one of your exemplary type people called the police or did anything to help. I quickly got Lillian and left to make sure we would be safe. I know you don't consider me exemplary but something tells me that boy, his friends, and their families my think I am a nice guy at least. I don't tell you this in any way to do anything other than show you this is who I am. What happened when I was a young and inexperienced male is not who I am today. The story you read in the paperwork is the lies the prosecutor told and the only explanation for your refusal to accept that is the recording of my ex showing her and Principal Stewart working together to keep me out of my daughters school life as much as possible. You all would rather support that then accept and admit to mistakes or the truth. I don't expect anything to change until I take Mr. Erdmans advice to make it change. I am in the process of that now. Exemplary people don't have to hide their actions with redaction.
