Dear Mr. Dodgen:

This letter provides the first installment to your request for public records, received in your email dated April 6, 2021, seeking the following:

*"I would like to request any documented report of racism at brier elementary and in the Edmonds school district for the last ten years. No matter who those reports are made by I would like to know what they are. Obviously names will have to be redacted but ethnicity should not be redacted as that is vital information as I would particularly like to know how many ethnic minority parents and or students have made formal complaints of racism at brier elementary and or in the Edmonds school district. But I want you to know of each and every incident for the last decade. Any and all official complaints of racism by staff, students, parents and or volunteers for the last decade just like the one that I've read in the emails about a teacher wanting to know what resources are available to deal with a young racist elementary School student but I did not see any notification of the parent? Especially since principal Stewart has chosen to not answer my question as to what the school and the districts reaction to these issues are."*

Public records found to be responsive to your records request are attached electronically to the email providing this response. A school business day shall mean any calendar day, exclusive of Saturdays, Sundays and any federal and school holidays, upon which the office of the superintendent is open to the public for the conduct of business. A student on emergency expulsion is not allowed to participate in or attend any school district sponsored activity and cannot be on or in the vicinity of any school or district property. Failure to comply with this regulation will result in further disciplinary action
