- The worksheet labeled "2020 2021 Records" are public records request we received through the district website from August 3, 2020 to August 20, 2021.
- The worksheet labeled "Historical Data" is a log of public records request we received from September 22, 2014 to July 20, 2020. During this timeframe, we were using a different system from that described above.
