On Saturday March 19, 2022 at approximately 0356 hrs I, Deputy Klemp responded to San-Dees Pub located 1570 Ferry Rd in the Town of Grand Island for a report of a female that was struck in the face with a pool cue. Upon my arrival I noticed a female, identified as Megan Barnes, laying on the floor of the bar with a bloody nose and several patrons around her. Deputy Bauer and I spoke with several witness who all stated that the female victim got into some sort of altercation with a male named Charles Vacanti. Charles then took the pool cue that was in his hand and struck Megan in the face with the end of the pool cue.

- I Deputy Klemp did processes the scene as a CSI Technician and did the following:
- Took photos of the scene, victim, and weapon (pool cue)
- Collected the pool cue as evidence

Megan was evaluated on scene by medical and refused treatment/transport to a hospital.

Due to the intoxication of parties involved patrol to follow up at the beginning of the shift(1800hrs) on 03/19/2022.

On March 19, 2022, at approximately 1754 hours, Deputy Bauer spoke with the assault victim Megan Barnes over the phone. Megan stated she was going to talk with her boyfriend Matthew Withiam-Leitch then come to the Grand Island substation to give a supporting deposition and to have additional photos taken of her injuries.

At approximately 1910 hours, Deputies Bauer and Klemp tried to call Megan Barnes back to see where she was. Matthew Withiam-Leitch answered the phone. Matthew stated that Megan would not be coming to the station today.

Deputies then called Megan's father, Michael Barnes, in an attempt to convince him to have Megan come to the station. Again Deputies were told Megan would not be coming to the station till speaking with a defense attorney.

At this time case is close due to victim refusing to cooperate.
