This is the second letter this month, anymore complaints in the near future will result in formal charges and hearings brought against you.

You have been an excellent Officer with this department for the last 10 years. The last six months have not been the normal you. If you are having some sort of problems, feel free to to come in and talk to me about them. The Village Board and myself are willing to work with you.

OFFICER DENIS:

BE ADVISED THAT YOUR PERFORMANCE AS A POLICE OFFICER FOR THE VILLAGE OF FORT EDWARD, NY HAS BEEN BELOW STANDARDS SINCE JUNE OF 1992. I HAVE RECEIVED SEVERAL COMPLAINTS FROM OFFICERS OF THIS DEPARTMENT AS WELL AS OFFICERS FROM OTHER DEPARTMENTS. I HAVE PERSONALLY SPOKE TO ON SEVERAL OCCASIONS AND HAVE GIVEN YOU THE BENEFIT OF DOUBT.

HOWEVER, THREE INCIDENTS IN THE PAST WEEK HAVE MADE DECIDE TO WRITE THIS LETTER OF REPRIMAND AND WARNING.

INCIDENT #1- EILEEN SWEET VS CLIFFORD SWEET. THE ACCUSATORY INSTRUMENTS YOU MADE OUR WERE WRONG AND HAD TO BE RE-DONE BY ME. AT 7:45 AM 2/4/93 I TOLD YOU WHILE YOU WERE AT THE BUS STOP TO STOP AT THE PD AFTER YOU PUT YOURS SON ON THE BUS TO SIGN THE NEW ACCUSATORY INSTRUMENTS. YOU DID NOT SHOW UP UNTIL AFTER NOON TIME. YOU KNEW THAT IT WAS SOMETHING THAT HAD TO BE TAKEN CARE AS SOON AS POSSIBLE BUT YOU CHOSE TO TAKE YOUR TIME IN GETTING HERE. AS A RESULT I HAD TO SIGN THE ALL THE PAPERWORK. THERE WAS NOT AN INCIDENT REPORT MADE OUT AND I HAD TO TELL YOU TO MAKE ONE OUT AFTER TELLING YOU VERBALLY AND IN WRITING ON SEVERAL OCCASIONS TO MAKE OUT INCIDENT REPORTS.

INCIDENT #2- YOU ARRESTED LAWRENCE HAVENS FOR A B MISDEMEANOR AND DID NOT DO AN ARREST REPORT OR FINGERPRINT THE SUBJECT. YOU WILL BE IN COURT ON THE 11TH OF FEBRUARY AND PROCESS HIM.

INCIDENT #3- YOU TOOK AN AGGRAVATTED HARASSMENT COMPLAINT FROM A HEATHER FREDERICKS, REFERRED HER TO THE PHONE COMPANY BUT NEVER MADE OUT AN INCIDENT REPORT. THIS WILL ALSO BE DONE AS SOON AS POSSIBLE.

CONDUCT OF THIS NATURE WILL NOT BE TOLERATED AND IF CONTINUED YOU WILL BE TERMINATED AS A POLICE OFFICER FOR THE VILLAGE OF FORT EDWARD. THIS LETTER OF REPRIMAND WILL BE PLACED IN YOUR PERSONNEL FILE.
