We will not be producing your request for **student email address** since they are not recognized by the University as Directory Information under the Family Educational Rights and Privacy Act (20 U.S. C. §1232g)

At this time, we have made a good faith estimate of the fees necessary to produce the records you have requested. There is no charge for the first 4 employee hours required to respond to your request.
