PO Baskin did not show up for his assigned shift on October 30, 2016. He was scheduled to work the day shift, from 0630-1500. He did not call and say that he was going to be late for work or that he was not coming to work at all. PO Baskin was scheduled for this shift for over seven days, as marked on the schedule. This is in violation of section 305 (III. A. 5) of the Geneva Police Department General Orders. I attempted to contact PO Baskin via cell phone but was unsuccessful on the first try at 0631. I called him again at 0632, at which time PO Baskin did answer and advised he would be on his way to work, and it would take approximately 30 minutes for him to get to work. He advised me that he did remember he was scheduled for the day shift, but forgot to set his alarm the previous night. He reported for duty at about 0715 hrs.

You must understand that this counseling memo is being completed so that you may take immediate corrective measures so it does not happen again. You must take precautions as stated in GO 305 (III. A. 5), so that this type of situation does not occur again.

PO Baskin did not show up for his assigned shift on May 15, 2016. He was scheduled to work his regular 1430 hrs. to 2300 hrs. shift. He did not call and say that he was going to be late for work or that he was not coming to work at all. After speaking with Lt. Valenti it was learned that PO Baskin had requested the day off but that request was denied due to a shift coverage shortage. It appears that PO Baskin never checked the schedule to see that he was still assigned to work on May 15, 2016. This is in violation of section 305A(5) of the Geneva Police Department General Orders. I attempted to contact PO Baskin via cell phone but was unsuccessful and his voicemail was not accepting messages. I also had Sgt. Colburn from the Ontario County Sheriff's Office check PO Baskin's house to see if he was home. He was not. When PO Baskin saw the missed calls, he did call and speak with me. He advised that he thought he had the day off and that he had just gotten back in town. He stated that he would quickly shower and be in for the rest of his shift as soon as possible. He reported for duty at 1730 hrs. and took over the dispatch desk as that was his assignment for the day.

You must understand that this counseling memo is being completed so that you may take immediate corrective measures so it does not happen again. You must take precautions as stated in GO 305A(5), so that this type of situation does not occur again.

Written narrative: On December 26,2015 at approximately 2221 during an incident at which included a fight/assault involving numerous subjects and six knives, you were directed to stay at the location and back up Officer J. Lloyd who was waiting for the homeowner to secure her residence. This Sergeant directed you to back up Officer Lloyd because of the seriousness of the crime involved, the lack of any street lighting and the subjects involved. After a short period of time, you cleared yourself and left the area, leaving Officer Lloyd alone. A short time later, you were located standing in dispatch. Your failure to obey a lawful order of a superior officer is in violation of General Order 105 III C as well as General Order 305 III 18 A.

You must understand that this written memo is being completed so that you may take immediate corrective measures so it does not happen again. You must take precautions as stated in General Order 105 III C and General Order 305 III A, so that this type of situation does not occur again.
