During your shift you did not document any property checks at all. You have been previously warned that you must physically complete and document property checks on your post. Property checks are an important aspect of Police patrol duties. Your failure to document property checks is a direct violation of General order 415, Post Assignments and patrol procedures section III B 5 of the Geneva Police Departments General Orders manual.

You must understand that this counseling memo is being served upon you so you may take immediate corrective measures so it does not happen again.
