<u>Specific complaint</u> — While driving your truck on at approximately 12:20 A.M. on **Exercise Contract Provide** you were stopped for a traffic check by Police Officer Steve Vine. The questions he asked you and the psychosomatic tests he asked you to perform are standard for driving while intoxicated investigations. At the conclusion of the tests Officer Vine determined you were sober and allowed you to continue on your way.

Finding – Exonerated – The act occurred and was legal, proper and justified.

Through our investigation and my conversations with you, I have concluded that Police Sergeant Tyler Turner violated our General Order Rules of Conduct and will be dealt with internally by my office.

finish my beer and the second was trying to get me to go to another bar but I refused and
told him I was going to go get my take out food I ordered earlier in the night at

phone numbers and he left with his friends. After they left I finished my beer and said
good night to retrieve my food. I talked to
for probably $10 - 15$ minutes and then I left. When I left of the for the
second time it was approx. 12:15am.

My truck was parked in the "free" parking lot and parked on the side of the

As I got into my vehicle I made 100% sure to buckle my seat belt and told myself to make sure I use my blinker at all times, come to complete stops, and go the speed limit. The reason for this is because I have had a very uneasy feeling since beginning of January 2009 because of the Tyler Turner situation I was sucked into. I had a gut feeling that he was after me and I was being targeted by him because of two prior incidents that I had with him. I had been extremely careful and took no chances to put myself in a situation that I knew would give him a reason to pull me over. The week before on a Saturday night out at **solution** I felt I was ok to drive but I decided to leave my truck in front of **solution** and get a ride home with **solution** because I probably had 5-6 beers that evening. I just did not want to give him any reason to pull me over. As I left the parking lot I exited the parking lot onto the and made 1000% sure I used my blinker when I turned left heading towards the trattic light at the intersection of the streets. At the light I took a right and again I made 1000% sure I used my blinker to make a right towards the stop sign at intersection of street. At the stop sign I made sure 1000% that I came to a

complete stop and put turn signal on and headed north on **second towards** my home. As I got to around the **second towards** I noticed a Police vehicle behind me probably 200 or more yards. I looked at my speedometer and I made sure I was going 30 miles per hour. As I glanced at the speedometer I noticed I was going around 28 miles per hour. A I continued on my way home I kept glancing in my rear view mirror and noticed the Police officer kept the same distance behind me the whole way until he put his lights on and pulled me over on opposite side of street form **second to be pulled over other than maybe I had a** light out on my truck. Right from the beginning I knew that me being pulled over was VERY VERY wrong!!

I was pulled over on Thursday it approx 12:15am by a Geneva City police officer on icross from As the officer came to my truck window I rolled my window down and he asked to see my driver's license, registration, and my insurance card. I had both my driver license and my registration but I could not find a current insurance card. As I was looking for the current card I had 3 expired cards in my hand and the officer sarcastically told me that he could give me a ticket for having expired insurance cards. I told him that I would throw them away as I was still looking for my current insurance card. As I was still searching the officer asked me if I had been drinking. I told him that I had two beers the whole night, one at approx. 9:30pm and another around 20 minutes ago, (which would have been around midnight). The officer then asked to see my eyes so I turned my head to the left and he shined his flashlight into my eyes. After he did this he asked my to follow the tip of his pen as he moved it with my eyes so I did. After I followed the pen with my eyes the officer asked me to turn off my car and to step out as he wanted me to do a few more sobriety tests. I then asked the officer what I was pulled over for! The officer said that I did not put my blinker on coming out of the the parking lot and that I did that right in front of him and that I crossed a double yellow line. Right then I knew that the officer was 1,000 percent wrong as I knew for sure that I put my blinker on coming out of the parking lot but I did not say anything to the officer and then did as he asked and turned off my truck and got out of it. As I reached the back of my truck the officer told me that he wanted to give me another test and asked me to put my hands to my side as not to balance myself and put my feet side by side and when he said start then he wanted me to put my right foot in front of my left and walk on the white line and count 1,000 and 1 and so on until I reached 1,009 then turn with my in step right foot and do the same back to him. He then said not to start until he said to. I did this test with no problem whatsoever! The officer then said he wanted to give me one more test -I said fine. The next test was he wanted me to both my feet together side by side and my hands to my side then raise my right foot 6" off the ground in front me and count 1,000 and 1 and so on until he said stop. He then said not to start until he said so. When I did this test you have to understand that it felt

like it was 10 degrees outside and the wind felt like it was blowing 25 miles per hour. AS I started this test I got to about 1,000 and 10 and then I lost my balance. I then said to the officer that I was nervous because I was never in this position before and that it was very windy out. I immediately raised my right foot and started the test again and started counting 1,000 and 1 until I got to 1,000 and 13 and I then put my foot down on my own and said that I thought that that was long enough. The officer said nothing and then said he wanted me to do one more test. He told me to put my hands out to my side with my index fingers extended and then close my eves and when he commanded right or left he wanted me to touch the tip of my nose with my index finger. He then said not to start until he said so. I did this test with no problem whatsoever! The officer then said he wanted me to do one more test. He said he wanted me to tilt my head back and close my eyes and in my mind count to 30 seconds and then tell him when I was done. The officer said not to start until he said so. When the officer said begin I did exactly as he asked and counted to myself 1,000 and 1 till' I reached 1,000 and 30 then I straightened my head and told him I was done. As opened my eyes and straightened my head I noticed the officer was standing next to another officer that was on the scene and he was looking at his watch. I did this test with no problem whatsoever! The officer then came over to me and said he wanted to give me one more test and I then said that I did all the tests that he had asked and that I was not doing any more tests! I then told the officer that what he was doing to me was bullshit and that after every test he gave me you said one more test and that I did them all! I told the officer to either fuckin" arrest me right NOW or to let me fuckin' go! I then told the officer to arrest me and that I would do any fucking test he wanted me to do at the police station and that I would blow into a breathalyzer or do any other fucking thing he wanted me to do! I then told him that after I got done with the breathalyzer that they both could blow me! I then said to him again, with my hands behind my back, to fucking arrest me or let me go!! The officer then responded after my tirade that they wanted to make sure that I was able to drive my vehicle. I said to him that I passed every fucking test you gave me and that if he was that unsure that I was unable to drive I told him to give me a ride home as I lived only up the road and I would pick up my truck in the morning. The officer said that if I left my truck there that it would be towed and that he could not give me a ride! I then told the officer that I would pay for the towing and to give me a ride if he was that unsure! The officer then asked me again to do the pen test and I told him no and that I was going to get into my truck and leave and as I was walking back to my truck he said to me "Well if you don't have your insurance card that I was going to get a ticket!" I then got into my truck and again started to search for my insurance card and could not find it. I then got out of my truck and told the officer that I could not find the fucking insurance card and to give me the fucking ticket and we would deal with it in court! The officer responded by telling me to get back into my truck so I didn't get hit by a car! I told the officer that why the fuck was he worried now about me getting hit by a car after he just had me out here for 20 fucking minutes doing those bullshit tests! I then got back into my truck and again began to search for my insurance card. As I searched for the insurance card I came across it in on of my other glove boxes. After I found it I got back out of the truck and went to the officer and told him that here was my insurance card and it is good until 2010! The officer then told me to get back into the truck and he would be right with me. I got back into the truck as he asked. As I got into the truck I was so pissed off because I felt I my constitutional rights were just

violated and I was shivering because of the cold. I decided to call my parents to tell them what had just happened. As I was talking to my mother the officer came to my window so I told my mother to hang on. As I rolled my window down the officer handed me back my insurance card and said you know were are just trying to give you a break here and he asked me AGAIN to follow the tip of his pen! I told the officer to stick the pen up his ass and that I was going home! I was rolling up the window and tried to put my truck into drive to leave the officer said to me sarcastically "You may want to start your truck before you go!" I was so pissed off as to what just happened to me I did not realize my truck was off! I then turned my truck on, put my seatbelt on, put my blinker on, and then took off. That evening I was so upset that I had called my sister, my cousin that is a cop in Tennessee, and my friend **and the metal state and the metal state and the state and metal state and the state and**

On Friday and the state of the ask me why I had changed my mind about swapping chairs that I had earlier agreed on. I that something had come up in the last few days and that I was not willing to talk told about it at that moment. The responded by saying to me "What's the matter you mad for getting pulled over the other night?" I told her that that was none of her business and that it was my business and it was being handled. **We** then responded and said "What do you think that you are special and that you should never be pulled over just because who you are!" I said to me "NO! And that I should have never been pulled over to begin with because I did nothing wrong!" Then said "Well from what I understand and know you were pulled over for three things! And that I was pulled over because I was drinking! I then told that I had 2 beers the whole night one around 9:30pm and another around midnight! The questioned me and said "You mean to ten me you would be at a midnight?" I told her NO and that I only had 2 sodas there and that I had the beer at ?" I told her NO and that I only had 2 sodas there and that I had the beer at the questioned me and said "You mean to tell me you weren't drinking at . I then told that I did not think that I needed to explain myself to her and that I was done talking to her and dealing with her boyfriend! I told her I had nothing else to say to her and if she wanted to talk to my in the future to call my lawyer or have her lawyer call mine and then I hung up on her.

I did not realize that Mr. Trickler and Chief Pane had not talked to Mr. Turner when had called me. I later found out from my conversation with Mr. Trickler that they had taken disciplinary action against Mr. Turner later that day.

Point 1: It is obvious Mr. Turner was involved in this illegal stop otherwise he would have not had disciplinary action taken against him.

Point 2: Both Mr. Trickler and Mr. Heick agreed during my initial conversation with them that they thought Mr. Turner had something to do with the situation. They both assured me that Mr. Trickler and Chief Pane would handle the situation and speak to Mr. Turner and the officers that pulled me over. I told both Mr. Trickler and Mr. Heick that I was not accusing Mr. Turner of anything because I had no proof that he was involved. I got the feeling that we all knew that he was involved in the matter in some way. Point 3: Is there not a confidentiality agreement in place at the Geneva Police department? Or is it regular practice for the officers to tell or to conspire with their girlfriends about official police business? As this is exactly what Mr. Turner did with my ex . There would be no other way would have known about this incident other than Mr. Turner telling her and then having her throw it back into my face!

There has been obvious and admitted wrong doing on behalf of the two officers that stopped me and Mr. Turner representing the Geneva Police Department and the City of Geneva. I will vigorously, at no expense spared, fight to protect my rights as a life long upstanding citizen of this community. My intention is to file a civil lawsuit against the three officers involved in this matter and the Geneva Police Department and to request a restraining order against Mr. Turner.

On **regarding** I was advised by Sgt Heieck that **regarding** wanted to speak to him regarding a traffic stop that he was involved in earlier in the morning. Sgt Heieck requested that I sit in on the conversation.

stated that on **boundary**^h he went to **boundary** and then later **boundary**. He stated that he had two beers the entire night and was not intoxicated. He stated that when he left to go home he made sure that his seatbelt was buckled and he followed every traffic law as he felt that he was being targeted by Sgt Turner due to Sgt Turner's

stated that he was eventually pulled over on

by

He stated that he felt the officers had no probable cause to make the stop and that he was unhappy with the overall stop and, again, that he felt he was being targeted. (see the formal statement regarding the traffic stop specifics.) wished to make a complaint against the officer's involved in the stop and he stated he would like it looked into whether Sgt Turner was involved or not as he had a feeling that he was. I asked him if he would like to give me the opportunity to look into the matter myself and handle the situation as I see fit depending on what I found out. **We** stated that he knew me and Sgt Heieck and that he trusted us and that he would be satisfied with me looking into. I advised him that I would investigate the matter, speak to the Chief about the incident and get back to him with my findings. I advised him that if Sgt Turner was in anyway involved in the incident in an inappropriate way the matter would be addressed. felt confident that it was going to be taken care of and the interview ended. After left I was advised by YO Potter that Sgt Turner had already called PO Vine to inquire what he was going to say about the incident if he happened to be interviewed.

When arrived at the PSB YO Potter observed him and requested to speak to me. I talked to YO Potter before I conducted my interview with . YO Potter advised me that was involved in a traffic stop with PO Vine and PO Mortier being the back up. He stated that after he heard the traffic stop was completed he requested to make a meet with PO Vine. He stated he asked PO Vine why he stopped the vehicle and that PO Vine told

him that Sgt Turner told him to keep an eye on it. YO Potter stated that he then explained to PO Vine what the connection was between Sgt Turner and PO Vine was. YO Potter also advised me that Sgt Turner contacted PO Mortier, while he was on his way home after his tour of duty to ask him how the traffic stop went.

I interviewed PO Vine. PO Vine was visibly upset about the incident. PO Vine stated that he was contacted by Sgt Turner to make a meet. He stated that he met up with Sgt Turner and that Sgt Turner wanted him to keep an eye on a vehicle that was parked in the

He stated that the vehicle was parked a few rows down from another vehicle that Sgt Turner repeatedly tells them to keep an eye on. He stated that Sgt Turner advised him to keep an eye on the vehicle and that the operator was probably going to be intoxicated. He stated that he went to talk to an off duty who was in front of when the vehicle in question exited the parking lot without using the vehicle's turn signals. He stated that he followed the vehicle north bound on and that the vehicle crossed the center line once and the fog line once. He conducted a traffic stop on the vehicle and commenced a DWI investigation. He stated that the operator was highly irate and agitated and being difficult. He stated that although the operator failed three or four test he felt that he did not have enough to arrest the operator for DWI. When asked why he didn't write any of the other violations that he observed he did not have an answer. I asked him if he knew the connection between the operator of the vehicle and Sgt Turner and he stated that he did not until he met up with YO Potter and PO Bielowicz and they explained it to him. PO Vine stated that before he went off duty Sgt Turner approached him and inquired about the traffic stop and why the operator wasn't arrested.

I interviewed PO Moriter regarding the incident. He stated that he showed up on the traffic stop and observed the operator to be very difficult and irate. I asked him if Sgt Turner contacted him about the stop. He stated that he was almost home when he got a phone call from Sgt Turner. He stated that Sgt Turner did not ask about the traffic stop but that he did ask a lot of questions about how the operator was acting. He stated that Sgt Turner called the operator a "tool" and a "loser"

I contacted Sgt Turner at home to advise him of the complaint and to advise him that he was not to discuss the matter with the officers involved or hinder the investigation in any way. I asked Sgt Turner if he knew why I was calling him and he stated that he did not. I asked him if he knew about **Determine** and the traffic stop and he advised me that he didn't know what I was talking about. I advised him that I knew that he was lying to me and that I already knew that he had contacted PO Vine to inquire what he was going to say about the incident. When I pressed him about this he agreed that he lied to me and that he knew what I was talking about. The bulk of the conversation had to do with advising him that he was not to speak to the other officers about it. I didn't get into detail

about the specifics because I had already advised the Chief about it and he wanted me to hold off until we had further information. I did ask him if he advised PO Vine to keep an eye on the vehicle and he stated that he did. I asked him why he did this and said that he felt that the operator would be intoxicated. I asked him if he knew who's vehicle it was when he told PO Vine to watch it and he said that he did. I advised him that he was not to have any contact with **second** and that I would be speaking to him about the specifics at a later date.

These were just preliminary interviews and more in depth interviews were to take place until **responded** to the PSB with a statement and requesting to make a formal complaint. Information turned over to Lt Cataline.
