State Constitution, and a Violation of Mr. Yezek's Constitutional Rights pursuant to 42 U.S.C. § 1983.

4. **Description of Claim and Time, Place, and Manner:** On July 20, 2018 at approximately 3:15 p.m., police officers Richard Cooper and Sean Hotnich committed a flagrant violation of Mr. Yezek's constitutional rights by entering Mr. Yezek's home without a search warrant and in the absence of probable cause. Based on the following allegations, it is clear that the Village of Gowanda police department harbored feelings of contempt towards Mr. Yezek, and this initial violation of his constitutional rights was no mere accident. The Village of Gowanda police department took concerted action against Mr. Yezek to ensure that he suffered as much harm as possible before he ever had his day in court. Detailed below are multiple violations of Mr. Yezek's constitutional rights which all stemmed from Officer Cooper and Officer Hotnich's initial violation of Mr. Yezek's Fourth Amendment right to be free from unreasonable search and seizure.

According to the Gowanda police department complaint information, a complaint was made by an anonymous caller of a "noxious" odor of marijuana emanating from Mr. Yezek's property at approximately 3:12 p.m. on July 20, 2018 (see Exhibit A). Upon information and belief, the anonymous tip was provided by Eugene Styles, 92 Buffalo Street, Gowanda, New York 14070. Attached hereto as Exhibit B is a Google Maps printout demonstrating that Mr. Styles lived nearly a mile from Mr. Yezek's house. Video surveillance footage from Mr. Yezek's property shows that Mr. Styles was never anywhere near Mr. Yezek's house on July 20, 2018. It is inconceivable that Mr. Styles could identify Mr. Yezek's property

as the source of the marijuana smell when he was nearly a mile away from his property.

Although a recording of the 911 call has not been made available to Mr. Yezek, upon information and belief, the 911 dispatcher made no efforts to verify or check the reliability of the facts disclosed by the individual providing the anonymous tip.

Based solely upon this anonymous tip, Officer Cooper and Officer Hotnich were dispatched and arrived at Mr. Yezek's property at approximately 3:15 p.m. When Officer Cooper and Officer Hotnich arrived, Mr. Yezek was sitting in his dining room area with his blinds closed and the door from his back room to his kitchen closed. Prior to Officer Cooper and Officer Hotnich's arrival, Mr. Yezek had been sitting in his dining room on his phone for at least fifteen minutes texting and researching different paints for the bed of his truck. Upon their arrival, without conducting any investigation whatsoever, Officer Cooper and Officer Hotnich immediately walked towards Mr. Yezek's back porch even though they parked right next to Mr. Yezek's side door which had a sign that read "NO TRESPASSING" and another sign that told visitors to use the front door with an arrow that pointed towards the front door. When Officer Cooper and Officer Hotnich reached the back deck, they discovered a doorway that led to Mr. Yezek's back room. The screen door was closed, and the back security gate was opened slightly. The video surveillance footage clearly shows that Officer Cooper pulled open the screen door, and then lightly knocked on the back security gate. Officer Hotnich then tapped once on the back security gate and simultaneously pushed the security gate open with his fingers. After he opened Mr. Yezek's back security gate, Officer Hotnich walked into Mr. Yezek's back room followed by Officer Cooper.

When Officer Cooper and Officer Hotnich entered Mr. Yezek's back room, they discovered that the door leading from the back room to the kitchen was closed. The back room does not lead to any room in Mr. Yezek's house besides his kitchen. Up until this point, Officer Cooper and Officer Hotnich made no effort whatsoever to announce their presence or their purpose. In an effort to deceive Mr. Yezek, the officers called out "Dave" from behind the back room to kitchen door, and when Mr. Yezek asked "who is it?" the officers opened the door and started walking into Mr. Yezek's kitchen. Mr. Yezek immediately got out of his chair, met Officer Cooper and Officer Hotnich at the door, and yelled at the officers to stop and that they could not enter his home without a search warrant. Mr. Yezek said to the officers "I got a front door. What about my side door? What about knocking?" Officer Hotnich told Mr. Yezek "we've been knocking for the last five minutes. We had a 911 call from a neighbor. We always use the back door." Mr. Yezek told the officers again that they could not come in without a search warrant.

Officer Hotnich started to push Mr. Yezek back into his dining room, and Officer Cooper pushed Officer Hotnich forward into the dining room. Mr. Yezek kept his hands by his side, and just tried to stand in the way to keep the officers from illegally entering his home. Officer Hotnich grabbed Mr. Yezek's shoulder, turned his body around, and then continued to push Mr. Yezek from behind into the dining room. Officer Hotnich immediately started to search a container on Mr. Yezek's table. When he did not find any illegal substances in the container, he continued to shove past Mr. Yezek into the living room. From the living room side of the dining room table, Officer Hotnich noticed a brown paper bag underneath Mr. Yezek's table. Officer Hotnich put the brown paper bag on Mr. Yezek's table and pulled out two bags of

marijuana. At this point, Officer Cooper and Officer Hotnich had walked through every room on Mr. Yezek's lower floor without a search warrant despite Mr. Yezek telling them repeatedly that they could not enter or search his house without a warrant.

Officer Hotnich immediately put handcuffs on Mr. Yezek with Mr. Yezek's arms in back of his body. He put the handcuffs on so tightly that they crushed Mr. Yezek's wrists which caused him severe pain. Officer Hotnich yelled at Mr. Yezek to tell the officers where the marijuana is. At no point had either Officer Cooper or Officer Hotnich read to Mr. Yezek his Miranda rights. Upon information and belief, an officer with the New York State police department arrived at the scene, and Officer Cooper and Officer Hotnich proudly displayed the two bags of marijuana on Mr. Yezek's table to the third officer at the scene. Officer Hotnich grabbed Mr. Yezek's handcuffed hands and started lifting Mr. Yezek's hands upward and behind Mr. Yezek's back. Officer Cooper and the third officer walked up to the second floor in Mr. Yezek's house, and one of the officers yelled "say, come up and look at this." Officer Hotnich yelled at Mr. Yezek "let's see what's upstairs now" and started to push Mr. Yezek from behind while holding his handcuffed hands above Mr. Yezek's head causing Mr. Yezek severe pain in both of his wrists and arms.

At this point, the Gowanda police department had searched <u>every</u> room in Mr. Yezek's house <u>without a search warrant</u>. Officer Hotnich left Mr. Yezek's house around 3:30 p.m. so he could obtain a search warrant. While Officer Hotnich was gone, Officer Cooper and the third officer continued to search Mr. Yezek's house while Mr. Yezek remained in the dining room. Officer Hotnich returned at approximately 3:40 p.m. without a search warrant.

It was not until approximately 5:03 p.m. that Officer Hotnich arrived at Mr. Yezek's house with a search warrant. From 3:40 p.m. to 5:03 p.m., a parade of individuals associated with the New York State, Cattaraugus County, and Village of Gowanda police departments had already entered and searched Mr. Yezek's home. In total, the video surveillance footage shows that no less than eight individuals entered and searched Mr. Yezek's home before a search warrant was obtained. The video surveillance footage also shows that Officer Cooper and other yet to be identified individuals took photos of the marijuana bags on Mr. Yezek's dining room table before obtaining a search warrant. Upon information and belief, Officer Cooper and the other yet to be identified individuals took pictures with their cell phones of the marijuana and marijuana plants found on Mr. Yezek's property and texted those photos to family, friends, coworkers, and news reporters before a search warrant was ever obtained.

The information contained in the application for a search warrant demonstrates that Officer Hotnich <u>lied</u> to the Court Justice for the Town of Persia in order to obtain the search warrant and cover up the fact that they entered Mr. Yezek's home without probable cause and without permission from Mr. Yezek. For instance, according to the application for a search warrant, Officer Cooper and Officer Hotnich announced themselves before entering the back room, but this is a lie (see Exhibit C). Officer Hotnich also told the Court Justice that they knocked on the door leading from Mr. Yezek's back room to his kitchen, and that "the door was partially opened from knocking." This, however, is impossible because the door leading from Mr. Yezek's back room to his kitchen pulls open. Officer Hotnich lied again when he said he yelled out "Hello," and that Mr. Yezek then said "come in." Officer Hotnich continued to lie when he told the Court Justice that he observed a "large amount of marihuana on the dining

room table." The marijuana Officer Hotnich discovered was down inside a brown paper bag underneath Mr. Yezek's dining room table. It was not in plain view, and the officers had no right to search for it without obtaining a search warrant. Officer Hotnich knew this, and he lied to cover up his misconduct.

Officer Hotnich also lied to the Court Justice when he said he "noticed extremely loud music coming from the upstairs window." The music was coming from Mr. Yezek's small portable radio which he kept right next to his upstairs window. The radio is more than 30 years old, and Mr. Yezek kept his window open so that he could hear the music while he was outside working on his truck. Officer Hotnich swore to the statements in his application for a search warrant, and therefore, his lies on the application were an act of perjury.

Upon information and belief, Officer Hotnich's application for the search warrant was brought to Mr. Yezek's property along with the search warrant on July 20, 2018. The other officers at Mr. Yezek's property read the search warrant and Officer Hotnich's application for a search warrant. The video surveillance footage shows one of the officers repeatedly simulating pulling the door to the back room open two minutes after Officer Hotnich arrived at the scene with the search warrant, appearing to question Officer Hotnich's sworn statement that he knocked on the back door leading to the back room and that "the door was partially opened from knocking." However, this officer did not raise any of the doubts that he had about the validity of the initial search by Officer Cooper and Officer Hotnich, nor did he bring attention to the fact that the search warrant may have been obtained illegally. In short, he was complicit in the violation of Mr. Yezek's constitutional rights.

The search warrant that Officer Hotnich obtained stated that the officers were directed to seize "Marihuana, Marihuana Grow Equipment and Paraphernalia, Records and/or proceeds of illegal drug actions, and weapons." In addition to these items, the officers <u>illegally</u> stole Mr. Yezek's driver's license, garbage bags, and cell phone. The video surveillance footage clearly shows Officer Hotnich stole Mr. Yezek's driver's license <u>even before he obtained the</u> search warrant.

While in custody at the Gowanda police station, Officer Peter Randall told
Mr. Yezek that he wanted him to sign a document stating that Mr. Yezek had been read his
Miranda rights. Mr. Yezek informed Officer Randall that he had not been read his Miranda
rights at any time. Officer Randall did not bother to read Mr. Yezek his Miranda rights. Instead,
Officer Randall became very angry with Mr. Yezek. Officer Randall got up from behind his
desk, walked around to the front and stood in front of Mr. Yezek. Officer Randall threatened
Mr. Yezek with physical harm unless he signed the document. He yelled at Mr. Yezek "Don't
give me any of your f***ing attitude. I'll bash your f***ing teeth in." At this time, Mr. Yezek
had his right hand and leg secured to the bench that he was sitting on. Mr. Yezek signed the
document stating that he had been read his Miranda rights.

Officer Randall also prepared two accusatory instruments against Mr. Yezek (see Exhibit D). The Complaints, dated July 20, 2018 and sworn to by Officer Randall on the same date, accused Mr. Yezek of Criminal Possession of Marijuana in the First Degree, a Class C Felony, and Growing Cannabis Without a License, a Class A Misdemeanor.

After Mr. Yezek's arraignment hearing on July 20, 2018, Officer Randall was tasked with transporting Mr. Yezek from the courthouse to the Cattaraugus County Jail. On the way to jail, Officer Randall stopped at Mr. Yezek's house while the other individuals associated with the New York State, Cattaraugus County, and Gowanda police departments were still searching Mr. Yezek's house. Officer Randall left Mr. Yezek handcuffed in the back of his police vehicle with the windows up in the middle of the summer. After about 10 minutes in the car, Mr. Yezek started to burn up. Mr. Yezek could not breathe and he started to panic. He yelled for help until Officer Cooper suddenly appeared and said "sorry, I didn't know you were in here." Officer Cooper let Mr. Yezek out of the vehicle. Mr. Yezek's clothes were soaked with sweat. A female officer who, upon information and belief, was a Cattaraugus County police officer, saw Mr. Yezek standing in the driveway and put him in her vehicle. Mr. Yezek begged the female officer to not leave him in the car with the windows up. The female officer allowed Mr. Yezek to keep the windows to her vehicle open, and she drove Mr. Yezek to the Cattaraugus County Jail.

Mr. Yezek was immediately placed into solitary confinement at the Cattaraugus County Jail where he remained for three days and two nights. To add even greater insult to injury, on July 21, 2018, one day after Mr. Yezek's illegal arrest and before Mr. Yezek ever had his day in court to contest the warrantless search of his home, the Gowanda police department posted on their Facebook page a WKBW news story about their arrest of Mr. Yezek. The Gowanda police department added a comment under the post <u>from their official Facebook</u> account that read:

The Village of Gowanda Police Department will actively pursue and prosecute the illegal sale and use of illegal substances in our community. It is our sworn duty to keep the citizens of Gowanda safe and secore [sic] in their community.

Included with the WKBW story were photos obtained by the police officers as a result of their warrantless and illegal search of Mr. Yezek's home. In other words, before Mr. Yezek ever had a chance to defend his innocence in a court of law, the Gowanda police department violated Mr. Yezek's due process rights and ensured that his name and reputation were forever tarnished. After the WKBW story was published and posted on the Gowanda police department Facebook page, The Buffalo News, Sunday Observer, and Gowanda/Lakeshore Pennysaver all published their own news stories about Mr. Yezek's arrest, including identifying information such as Mr. Yezek's full name, address, and age. All of these news stories reported the Gowanda police department's version of the facts of Mr. Yezek's arrest, facts that Mr. Yezek still had not been able to contest.

Mr. Yezek was able to bond out of jail Monday morning, July 23, 2018. When Mr. Yezek finally returned to his home, he found that the officers had completely disrespected his home and left it a total mess. The inside of the house was covered with dirt, his heating ducts were torn apart and broken, and the officers caused unnecessary damage to his dishes.

Mr. Yezek was so distraught by this mess that he stayed with his friend, Felicia Pope and her husband, Chris Pope, for the first two nights after bonding out of jail.

On November 28, 2018, a Gowanda police officer drove by Mr. Yezek's house while Mr. Yezek was shoveling and asked him if Officer Randall took his fingerprints when he was arrested. Mr. Yezek answered the officer affirmatively, and the officer said "the same [officer] who threatened you?" Mr. Yezek answered "yep, that's the one." The officer drove off. Upon information and belief, the officer's sole purpose for this interaction was to maliciously harass Mr. Yezek.

On December 7, 2018, Mr. Yezek was harassed again by the Gowanda police department. This time, it was Officer Hotnich. Mr. Yezek was at the Village of Gowanda Town Hall paying his water utility bill when Officer Hotnich approached him and said that he needed to speak to Mr. Yezek. When Mr. Yezek tried to walk around Officer Hotnich, he stood in Mr. Yezek's way and blocked the doorway. Mr. Yezek was eventually able to step around Officer Hotnich, and as he did so Officer Hotnich threatened to get a court order from a judge to force Mr. Yezek to speak with him. Officer Hotnich also told Mr. Yezek "I liked your Halloween decorations" as Mr. Yezek was walking away, implying that the Gowanda Police Department was keeping surveillance on his property to try and find a reason to arrest Mr. Yezek.

On March 4, 2019, Mr. Yezek was contacted by the Assistant Superintendent of Sweet Home School District, Joann A. Balazs, and Mr. Yezek met with her at Maplemere School. When he arrived, Ms. Balazs had on her desk print outs from the WKBW news story regarding Mr. Yezek's arrest, the same news story posted on the Village of Gowanda police

department Facebook page. March 4, 2019 was the last time that Mr. Yezek worked in the Sweet Home School District as a substitute teacher.

On May 14, 2019, Mr. Yezek arrived for work at Ellicott School in the Orchard Park as a substitute teacher. However, Mr. Yezek was sent home. Later that day, Mr. Yezek received an email from the Orchard Park School District informing him that all of his scheduled assignments were cancelled and that he will be receiving a letter soon about his future employment in the district.

On May 20, 2019, Mr. Yezek received a letter from the New York State

Department of Education informing him that his fingerprint clearance was on hold until his case was resolved. He also received a letter from the Office of School Personnel and Accountability of New York State Department of Education informing him that his fingerprints were on hold until an adjudication of the charges against him as well as providing to them a Certificate of Disposition.

All charges stemming from this July 20, 2019 incident were dropped against Mr. Yezek on July 29, 2019. The Cattaraugus County District Attorney, Lori Pettit Rieman, told Mr. Yezek that he could go to the law enforcement to retrieve his property, and that if there was a problem they could call the Cattaraugus County District Attorney's Office. Mr. Yezek went to the Village of Gowanda police department that day to retrieve his property, but he was told by Officer Green to return the next day because Officer Hotnich was in charge of the inventory and he was not there at the time.

Mr. Yezek returned to the Village of Gowanda police department on

August 1, 2019. Mr. Yezek told Officer Feldman his intention to file a complaint against Eugene

Styles for his false 911 call. Officer Feldman refused to assist Mr. Yezek with filing a complaint
against Mr. Styles, and said to Mr. Yezek "the only reason you got off was because the weed
never made it to the lab" and "I'm not taking any of your shit." Mr. Yezek asked politely to have
his property returned to him, but his request was denied. To obtain his property, Mr. Yezek was
forced to file a motion on August 19, 2019 with the Cattaraugus County Court seeking an order
demanding the law enforcement/police return his property. Mr. Yezek was told on August 30,
2019 by an employee in the Cattaraugus County courthouse that there was no need for him to
appear for the motion hearing on September 9, 2019 because the Judge was already drafting an
order to compel the law enforcement, Southern Tier Regional Drug Task Force, and New York
State Police return of Mr. Yezek's property.

Today, even though all charges against Mr. Yezek have been dismissed, the Village of Gowanda police department still has not deleted from its Facebook page the WKBW story concerning Mr. Yezek's arrest, nor have they deleted the comment from their official Facebook account associated with the post. A simple Google search of "David E. Yezek" will demonstrate that Mr. Yezek's character and reputation are forever damaged due to the Gowanda police department's unlawful search and trespass into his home (see Exhibit E).

In addition, Mr. Yezek has suffered eternal financial harm as a result of this incident. Not only did Mr. Yezek lose the \$5,359.93 loan from his retirement contributions and lose all future proceeds from that investment due to his early retirement; Mr. Yezek's chances to

secure permanent employment as a teacher have been destroyed as a result of this incident also affecting his retirement savings. Prior to his unlawful arrest, Mr. Yezek planned to seek a permanent position as a teacher in order to establish a new base salary for his retirement plan. The base salary for his retirement plan is determined by the average of his last three permanent jobs as a teacher. Mr. Yezek has now lost his ability to raise his base salary for retirement, an opportunity that can never be regained. Further, because it is nearly impossible for Mr. Yezek to secure work in his profession, Mr. Yezek can collect only a fraction of the social security benefits he otherwise would have if he was able to postpone his retirement.

As a result of this incident, Mr. Yezek lives in constant fear that the Village of Gowanda police department will illegally enter his home and arrest him at any moment. This has caused Mr. Yezek severe emotional and psychological distress. Prior to this incident, Mr. Yezek lived a simple life, a life that he was very pleased with. Since this incident, however, Mr. Yezek has had constant nightmares, suffers from insomnia, has severe depression, and even has had suicidal thoughts.

- 5. Items of Damage or Injuries Sustained: As a result of Respondents' unlawful conduct described in detail above, Respondents have caused harm to the public at large and to Mr. Yezek in the following respects:
 - a. The Village of Gowanda either ignored or negligently performed their duty to investigate several complaints made by Mr. Yezek;
 - b. Police officers violated Mr. Yezek's constitutional right to be free from unreasonable search and seizure by the government and other

- officers failed to either intervene or discipline the officers responsible for the violation;
- c. Police officers put their own self-interests and those of their department before Mr. Yezek's rights protected under the Constitution of the United States by publicizing the incriminating evidence discovered as a result of the unreasonable search of Mr. Yezek's home;
- d. Police officers verbally and physically abused and harassed Mr. Yezek for no reason other than to harm Mr. Yezek and intimidate him so that Mr. Yezek did not expose the misconduct of the officers;
- e. The Village of Gowanda police department continues to employ officers who exceed their authority and engage in unlawful acts by causing harm to members of the public in contravention of every citizen's Constitutional rights;
- f. Mr. Yezek was unlawfully detained, threatened, and subjected to malicious prosecution causing damage to his reputation, damage to character, damage to social standing, financial harm, injury to his standing as a teacher, damage to his home, suffering, emotional and psychological distress, and physical damages as a result of the unlawful conduct outlined in this Notice of Claim;

WHEREFORE, Claimant requests that the Respondents be held accountable for their unlawful conduct in connection with this claim. Respondents hereby are notified that unless this claim is addressed within the time provided by law from the date of presentation, the Claimant intends to commence a lawsuit on this claim, together with interests, costs, and disbursements.



Officers announced themselves and entered the porch at which time the odor of marihuana intensified. Officers then knock on the interior door and also noticed two addition pad locks on same. Patrol yelled out "Hello" a male subject said "come in, "then said who is it" the door was partially opened from knocking at as I opened I observed a male familiar to me as David E. Yezek. I also observed a large amount of marihuana on the dining room table. The odor of marihuana intensified even more. Mr. Yezek was taken into custody.

Third: On June 30, 2017, at 5:02pm, The David E. Yezek reported a burglary at his residence where he claimed that over \$50,000 in cash was taken from his residence.
