- Polls will be open from 7 a.m. to 9 p.m., at the elementary school in your attendance zone.
- Voter registration is required. (If you are currently registered to vote in county elections, you are also registered to vote in district elections.) If you are not registered, you may do so at any of the district elementary schools on May 5, May 9, or May 10 from 8:30 a.m. to 2:30 p.m. or at the district office (8 School Road, Guilderland Center) on the aforementioned days from 8:30 a.m. to 4:30 p.m.
- To vote, you must be at least 18 years old, a U.S. citizen, and a resident of the district for at least 30 days prior to the vote.

Proposed budget: \$109,887,845

- Budget-to-budget increase is \$4,908,275 (+4.68%)
- Tax levy increase is 2.98%, which is below the tax levy limit
- Tax rates estimated to increase by 2.98% for all towns

Bus and equipment proposition: \$976,000

- A separate proposition on the ballot seeks voter approval to purchase eight 66-passenger buses, three with chains
- Approximately 50% of the bus purchase would be returned to the district in the form of state aid

Board of Education election (3 three-year terms and 1 one-year term)

- Voters will select four board members from the following candidates (listed in the order they will appear on the ballot): Katie DiPierro, Nicole Coonradt, Kimberly Blasiak, April McAllister, Mark Reamer, Jennifer Romano, Kelly Person, William Keaney, Gloria Towle-Hilt, Barbara Fraterrigo

2022-23 PROPOSED SCHOOL BUDGET OVERVIEW

The proposed budget makes it possible to:

- maintain overall staffing levels
- maintain all current academic programming at all three levels
- lower class sizes in grade eight
- expand the AES library position from .6 to .8 FTE
- maintain all interscholastic and extracurricular opportunities for students
- meet the district's goal of educating the whole student, ensuring each and every student is ready to succeed in the future

A commitment to the whole student

Like most other school districts, GCSD is experiencing many cost pressures, including inflation that is higher than it has been in decades. Some of the challenges facing the district include significant cost increases next year for contracted transportation services, due to the nationwide shortage of available bus drivers as well as increased costs related to serving students with disabilities. This budget meets these needs and aligns with the district's goals of educating the whole student. In addition to robust academics, this budget supports the programs that contribute to the social and emotional well-being of GCSD students, such as music, the arts and athletics.

What is the impact of newly allocated federal funds on the 2022-23 spending plan?

GCSD was allocated \$4.9M in Coronavirus Response and Relief Supplemental Appropriations (CARES) and \$2.8M from the American Rescue Plan (ARP).

- The federal funds are **finite, meaning they are for a limited time period** and should only be used to cover non-recurring costs incurred as a result of the pandemic.
- These funds are **separate from the general operating budget** that is going before the voters in May.
- Funds are intended to be used for expenses that address items such as learning loss, student mental health needs, after school and summer learning, hardware and software for remote learning, PPE and air quality and ventilation improvements.

Guilderland's proposed tax levy is below the maximum allowable limit; a simple majority of voters (50 percent +1) is needed to pass the budget.
