Greetings MuckRock:

On behalf of the City of Citrus Heights, I am responding to your July 28, 2021 request for documents regarding City records pursuant to the California Public Records Act. You have requested the following:

Records Request No. 1:

All Documents constituting, reflecting, relating to or that contain current use policies if any for each type of 1033-program controlled equipment, including situations or circumstances in which use is authorized or prohibited.

- CHPD Lesson Plan Title Emergency Response Vehicle (ERV), Attached
- Special driver licenses and certifications are required and issuance is obtained and controlled through the DMV and/or Cal Trans
- The 1033 program is controlled by the Defense Logistics Agency's (DLA) jurisdiction. The program administrator is technically the Law Enforcement Support Office (LESO) located at the DLA headquarters in Michigan. States were required to set up MOA's with the DLA in order to participate in the program. Each state is required to assign a State Coordinator to ensure the program is used correctly by participating LEO's. The identified State Coordinator for each state is expected to maintain property accountability records and investigate any alleged misuse of property.
- View Cal OES's website to locate the current State Coordinator to obtain polices.

Records Request No. 2:

Records that list the dates, locations, suspected offense(s) or rationale for operation, controlled equipment deployed, arrests, and uses of force for each deployment of 1033-program controlled equipment since July 1, 2019, specifically: armored vehicles such as Mine-Resistant Ambush Protected (MRAPs) vehicles, firearms, and night vision equipment.

- Our records indicate (6) six deployments from July 1, 2019 – July 31, 2021.

- **Suspected Offenses:** Outside Agency Assist for the Sacramento Police Department
- **Rationale for Operation:** The Sacramento Police Department was investigating an illegal possession and sales of firearms case, which involved a high-risk search warrant.

- **Equipment Deployed:** ERV
- **Arrests:** Contact Sacramento Police Department
- **Use of Force:** N/A

2. Case: CH20-0228

- **Date:** January 10, 2020
- **Location:** 7711 Greenback Ln., #288, Citrus Heights, CA
- **Suspected Offenses:** Outside Agency Assist for the Santa Clara Police Department.
- **Rationale for Operation:** The Santa Clara Police Department was investigating 80 firearms being stolen involving subjects that resided in Citrus Heights, CA and were in possession of multiple handguns and rifles, to include machine guns
- **Equipment Deployed:** ERV
- **Arrests:** Contact Santa Clara Police Department.
- **Use of Force:** N/A

3. Case: CH21-00774

Date: January 30, 2020

Location: 7664 and 7666 San Simeon Dr., Citrus Heights, CA

Suspected Offenses: Outside Agency Assist for the Sacramento Police Department

Rationale for Operation: The Sacramento Police Department attempted a traffic stop, involving firearms, which turned into a vehicle pursuit and ended in a crash and a foot bail of a suspect.

Equipment Deployed: ERV

Arrests: Contact Sacramento Police Department.

Use of Force: N/A

4. Case: CH20-00846

Date: February 1, 2020

Location: 7217 La Luna Ct., Citrus Heights, CA

Suspected Offenses: Felony battery (243(d) PC), illegal possession of an assault weapon (30605(a) PC), felony vandalism (594(b)(1) PC), obstruction (148(a)(1) PC), and battery on a peace officer (243(b) PC).

Rationale for Operation: Barricaded subject with a firearm threatening to kill officers

Equipment Deployed: ERV

Arrests: The male suspect was taken into custody by CHPD.

Use of Force: N/A

5. Case: CH21-03933

Date: May 11, 2021

Location: 7313 Auburn Oaks Ct., #7, Citrus Heights, CA

Suspected Offenses: Assault with a deadly weapon warrant (245 PC) and shooting at an inhabited dwelling (246 PC)

Rationale for Operation: Shooting; Two suspects shooting and three victims with gunshot wounds

Equipment Deployed: ERV

Arrests: Suspect taken into custody.

Use of Force: N/A

6. Case: CH21-05088

Date: June 23, 2021

Location: 8219 Heritage Meadow Lane, Citrus Heights, CA

Suspected Offenses: Assault with a deadly weapon warrant (245(A)(1) PC) and illegal discharge of a firearm (246.3 PC), exhibiting a firearm in public, (417.8 PC), and resisting arrest (148(A)(1) PC).

Rationale for Operation: Suspect pointed a firearm at his father and officers on scene, fired various rounds from inside the house

Equipment Deployed: ERV

Arrests: Suspect taken into custody.

Use of Force: N/A

**Addendum to the State Plan of Operation between the State of California and
the Citrus Heights Police Department**


As of July 1, 2014, the DLA LESO has implemented policy and procedural changes that place additional controls on certain excess DOD property with Demilitarization codes of A and Q with an Integrity Code of 6. These items will be subsequently referred to as, "National Security Exemption (NSE) restricted DEMIL A and Q6 items". Section III-General Terms and Conditions, § G-H, has been amended via Section XXI-Addendum, to reflect the additional controls placed on these items.

1. The DLA LESO will maintain a list of National Security Exemption (NSE) restricted DEMIL A and Q6 items by National Stock Numbers (NSN) that will be treated as controlled property.
2. All items falling into this category that were acquired with an MRO/ship date after July 1, 2013, will be treated as controlled property, and will *not* be systematically archived from the DLA LESO inventory. Law Enforcement Agencies are not authorized to sell NSE restricted A and Q6 items.
3. When an NSE restricted DEMIL A and Q6 item is no longer needed by a Law Enforcement Agency, the item must be turned back into a DLA Disposition Services location or transferred to another participating Law Enforcement Agency within the DLA LESO.
4. For Annual Inventory purposes, Law Enforcement Agencies who obtain or have obtained NSE restricted DEMIL A and Q6 items after July 1, 2013, must now provide serial numbers for these items. In addition, photographs of these items may also be required if the item falls into a Federal Supply Group (FSG) of 10, 15, 19 or 23.
5. Law Enforcement Agencies may request to sell items with a DEMIL Code of Q with an Integrity Code of 6 that *do not* fall into the category of NSE restricted items, but must gain State Coordinator and DLA LESO approval *prior* to the actual sale of such items. These items will *not* be systematically archived from the DLA LESO inventory.
6. Only excess property with a DEMIL Code of A that *does not* fall into the category of NSE restricted items will continue to be systematically archived from the DLA LESO inventory one year from MRO/ship date. Title for items in this category will continue to pass to the LEA.

LESSON PLAN TITLE: Emergency Response Vehicle (ERV)

PURPOSE:

The purpose of this training is to provide students with a basic understanding of the Mine Resistant Ambush Protection (MRAP) vehicle, which has been repurposed as the Department's ERV. The training will cover basic operating procedures, capabilities, and utilization during preplanned and emergency events.

PREREQUISITE:

Operators must possess a valid California Driver's License with Class B and Airbrake endorsement before being designated as an ERV driver.

TIME:

4 Hours

OBJECTIVES:

Upon completion of this training, each student must be able to demonstrate a basic proficiency in the following areas:

- Basic maintenance and safety inspection procedures of the vehicle
- Perform an airbrake test and inspection
- Basic driving and parking maneuvers
- Passenger loading and unloading/ rear ramp safety procedures
- Turret operations automatic and manual
- Tactical considerations
 - Vehicle positioning
 - Tactical Medic considerations
 - Interoperability with Crisis Negotiations Team members
- Basic troubleshooting and repair requisition

PROCEDURES:

Instruction will begin, in a classroom environment, with a basic overview of the MRAP; including, but not limited to, vehicle components, nomenclature, and a review of safety procedures. Student will be provided with the MRAP maintenance inspection form and the airbrake inspection form. The instructor will provide an overview of MRAP capabilities and tactical considerations. (1 hour)

The next portion of training will occur in and around the MRAP. The instructor will familiarize students with the vehicle in a practical manner. The instructor will demonstrate a maintenance and safety inspection for the students. Each student will successfully perform a complete inspection of the vehicle including an airbrake test and inspection. (1 hour)

The instructor will demonstrate basic driving and parking maneuvers. This will include, at minimum, basic turning movements, parking, and backing maneuvers. Each student will demonstrate proficiency performing these basic maneuvers. (1 hour)

The final portion of training will cover operational considerations. The instructor will discuss vehicle considerations in a tactical environment. Students will undergo a series of practical exercises to simulate loading passengers, approach to a crisis site, tactical positioning, and offloading passengers. The instructor will discuss considerations relating to deploying tactical medics from the vehicle, recovering wounded personnel, and evacuating a crisis site. In addition, the instructor will cover consideration related to interoperability with the Crisis Negotiation Team related to positioning of public address equipment and communication with onboard negotiators. (1 hour)

ADDITIONAL PERSONNEL NEEDED/USED:

A minimum of two instructors are necessary to properly demonstrate MRAP safety protocols and safeguard students during exercises.

EQUIPMENT NEEDED/USED:

MRAP and full SWAT callout gear. Drivers may wear soft armor as applicable.
