BCI INITIAL ENTRY		
On 05/21/19, I was directed by Senior Investigator JOHN DIPASQUALE to review the contents of an email received by the New York State Governor's Office which alleges an incident of Aggravated Harassment by an unknown FBI Agent.		
I reviewed a copy of the aforementioned email, which was sent to the New York State Governor's Office by KEVIN RIFORD (complainant), who, in the email, states that he "whistle blew" on two Department of Homeland Security employees who were moonlighting as private investigators. RIFORD's email goes on to say that during a subsequent phone conversation with "DHS Internal Investigator Kelly Marshal" and a "Special Agent from Buffalo, NY named Brian Burns", "Brian Burns" could be overheard during the phone call stating, "let's kill him", "bring a handgun" and "lock-pick the car." RIFORD then indicated that this phone conversation was audio recorded and provided a web link, which contained the audio recording of this phone call as well
