I accessed the web link provided by RIFORD in his email and reviewed a website which is displayed as [misplacedpower.org/cbp-fbi/](http://misplacedpower.org/cbp-fbi/). The home page of this website is titled, "A Story of Misplaced Power & Corruption, a quest for accountability" and contains content naming several individual law enforcement personnel / government personnel involved in corruption and possibly an alleged conspiracy against RIFORD and his family members. Also observed on the webpage are numerous links to video and audio recordings of RIFORD and other family members engaged in contact with law enforcement and other government officials. Included in the audio section is the audio clip of the phone call referenced in the email to the governor's office. After listening to the audio clip, I was unable to decipher any of the specific threats indicated in RIFORD's email. No other evidence pertaining to the phone call in question was observed on the website.

**INTERVIEW OF KEVIN RIFORD, JOANNE RIFORD AND CHRISTINA LITTLE**

On 05/24/19, Investigator JOHN SPERO and I patrolled to 3038 Michael Drive in the City of North Tonawanda where we were met by KEVIN RIFORD (complainant) and his mother, JOANNE RIFORD (person interviewed). I attempted to interview KEVIN RIFORD regarding this incident, however, KEVIN RIFORD requested that we move the interview to Platter's Chocolate Factory, located at 908 Niagara Falls Blvd, North Tonawanda, NY.

Investigator SPERO and I immediately patrolled to Platter's Chocolate Factory at which time I interviewed KEVIN RIFORD and JOANNE RIFORD relative to this incident. KEVIN RIFORD stated that while making a complaint to the FBI regarding two unknown DHS employees working outside employment as private investigators, he and his sister, KATIE L. RIFORD (person not interviewed) were on a conference call with "Special Agent Brian Burns" and "DHS internal investigator Kelly Marshall when KEVIN RIFORD stated that he heard "Special Agent Brian Burns" state, "let's kill him", "bring a handgun", and "lock-pick the car". KEVIN RIFORD confirmed that the audio recording of this phone call, which is accessible through the website, [misplacedpower.org](http://misplacedpower.org), is a true and accurate copy of the original recording of the phone call in question. KEVIN RIFORD stated that the aforementioned threatening phrases can be heard in the audio recording of the phone call on [misplacedpower.org](http://misplacedpower.org). KEVIN RIFORD revealed that outside of this audio clip, there is no additional evidence specifically pertaining to his complaint. KEVIN RIFORD referenced widespread conspiracies towards he and his family members via town courts, law enforcement and other government officials.

Interview with JOANNE RIFORD revealed similar conspiracy theories alleging an ongoing continuous harassment of their family via local courts, law enforcement and government officials. JOANNE RIFORD stated that yesterday, 05/23/19, three black hawk helicopters flew over her daughters house in Tonawanda, NY as part of this ongoing harassment. JOANNE RIFORD could not add any relevant information to KEVIN RIFORD'S specific complaint.

While interviewing KEVIN RIFORD and JOANNE RIFORD, CHRISTINA C. LITTLE (person interviewed), who is KEVIN RIFORD'S sister and JOANNE RIFORD's daughter, arrived on scene to provide support for KEVIN RIFORD and JOANNE RIFORD's conspiracy theories. LITTLE could not provide any relevant information pertaining to this incident.
