On Tuesday April 11, 2023 I deputy Z. Allen was dispatched to the sheriff office in reference to a lobby call in reference fraud.

Upon my arrival I met with the complainant Charles Johnson. Johnson stated for roughly a year now he has been investing into cryptocurrency. Johnson stated his investments were turning into profits so he wanted to cash out. Johnson attempted to cash out when he was advised to send in an extra \$10,000. Johnson sent in the amount. The company then again requested \$5,000 to fully receive his earnings. At this point Johnson believed the company to be a scam.

Johnson stated he spoke with a foreign male subject who claimed to be a manager for the company " HKD.Com". The male then began requesting Johnson's banking passwords.

Over the course of the year Johnson has invested \$1,000 to \$3,000 several times. Johnson stated his total sum of investments were around \$90,000. Johnson was instructed to speak with his bank about the transactions.
