FOIA APPEAL

Dear Secretary Barrett,

In re FOIA request 2020-00855-F, this is to appeal:

1. Regarding Technical Order 0-1-11N, the Air Force's failure to respond to my request for that record, failure to adequately search for that record, and failure to release or make a determination of releasability of that record.
2. Regarding Technical Order 0-1-11N-1-CD-1, the Air Force's incorrect denial of my request for that record under exemption b(3) on the basis of 10 USC 1030, as well as its failure to release reasonably segregable portions of that record.

1. Please find attached my original request, submitted by email on 11/13/2019. In it I specifically request Technical Orders 0-1-11N and 0-1-11N-1-CD-1. I have attached two separate acknowledgement messages I received, both of which are signed by or otherwise attributed to named Air Force employees, and both of which specifically mention both Technical Orders.

I apologize for any confusion over any differences in email or mailing address on these messages, which can be attributed to the Air Force's opting to file the request under a PAL

account I had established for a separate request, rather than respond to the email and mailing address from which I had submitted this request.

On 10/16/2020 I received the Air Force's response, a file entitled "2020-00855-F-- Final Determination Letter" (attached), which states that is the agency's response to my request, and which denies release of Technical Order 0-1-11N-1-CD-1 without referring to Technical Order 0-1-11N, which the Air Force had already acknowledged I had requested.

I appeal the Air Force's failure to respond as required to my request for Technical Order 0-1-11N, and its failure to either release that record or make a determination as to the releasability of that record. I also appeal the adequacy of the Air Force's search for this record, insofar as I have not received it.

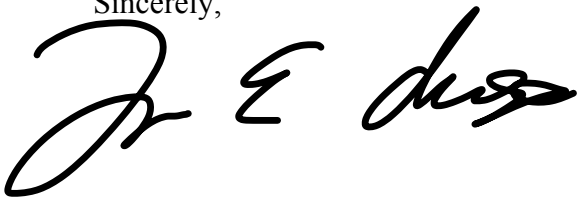
2. Regarding the agency's denial of the release of of Technical Order 0-1-11N-1-CD-1 on the basis of exemption 3 and 10 USC 1030, that statute permits the withholding of "technical data with military or space application", defined in the statute as:

blueprints, drawings, plans, instructions, computer software and documentation, or other technical information that can be used, or be adapted for use, to design, engineer, produce, manufacture, operate, repair, overhaul, or reproduce any military or space equipment or technology concerning such equipment

Public sources suggest Technical Order 0-1-11N-1-CD-1 constitutes an index of other Air Force Technical Orders. I assert that it does not constitute "technical data with military or space application" as defined in the statute. As such, I appeal the Air Force's unlawful denial of my request for Technical Order 0-1-11N-1-CD-1 by citing a statute that does not protect that record.

Separately, the cited statute refers to "data" and "information", not "records" or "documents", and only insofar as they meet the test that they "can be used, or be adapted for use" for the specified purposes. It is hard to believe that the *entire record* could constitute "technical information" **and** meet this test. As such I appeal the agency's failure to release reasonably segregable portions of this record.

Dear Mr. Durso,

We received your 10-Nov-19 Freedom of Information Act (FOIA) request 2020-00855-F on 06-Dec-19, which seeks the following: Copy of technical order 0-1-11N and technical order 0-1-11N-1-CD-1. Our organization has a significant number of pending FOIA requests which may prevents this office from making a response determination within 20 working days. Therefore, a multitrack processing of request has been instituted. Based on the information you have requested, your request has been placed in the Complex track. We find we are unable to meet the time limits imposed by the FOIA in this instance because the records must be reviewed by other agencies. We anticipate it taking up to two years, therefore we will continue to update you on the progress. Our policy is to process requests within their respective tracks in the order in which we receive them. FOIA request are processed quickly as possible. The FOIA Fee Restriction prevents DoD Components from charging commercial or "other" requesters search fees, or representatives of the news media or educational requesters duplication fees if respond do not occur within 20 or 30 working days for unusual circumstances (documents not located with the office processing the FOIA request, the responsive records are voluminous, or required consultation with another agency). Fee restrictions does not apply if responsive records total more than 5,000 pages and this office has made three or more good faith attempts to discuss with you, how to effectively limit the scope of your request. We have determined your fee category to be Other. Normally, under this category, fees would not be collected to recover the full direct cost of searching for and duplicating records, except that the first two hours of search time and the first 100 pages of duplication shall be furnished without charge.
