Like, I mean, I saw him when I was walking over, as I was leaving the thing, because I was parked on the side, not far from it. But the guy was like hiding from it, and he – and he kept on like peeking out and going back behind it. So, it just looked shady and I figured I'd let you know.

Male Speaker 2: Tell him that you know, hopefully, tell him to – you have the information. We can follow-up with him later. Uh, you know, as soon as he's out of Keene, we can't continue going that far over something like that.

Dispatcher: I'll just tell him we don't have anyone in the area, either.

Dispatcher: Because I have three guys going to a criminal mischief at – at Panera.

him.
