1. I request to inspect the following public records of the City of Troy.

2. I request copies of the following public records of the City of Troy. I understand that the first five (5) pages are free, there is a \$.50 charge for each page thereafter, for 8 1/2" x 11" and/or 8 1/2" x 14". Actual cost will be charged for other sized or formatted documents.

- 1) Any and all police reports, arrest records, and other related reports filed against Brandon Hicks, a former police officer at the Troy police department.
- 2) Any and all complaints, warnings, disciplinary action, and other related documents filed against former police officer Brandon Hicks when he was a police officer in the Troy Police Department;
- 3) The annual salary of Brandon Hicks as a police officer in the Troy Police Department in 2016, 2017, and 2018;
- 4) Official police rank of Brandon Hicks in 2018;
- 5) Year of first employment of Brandon Hicks at the Troy Police Department;
- 6) Reason for discontinuation of Brandon Hicks' employment at the Troy Police Department in 2018.
- 7) The name(s) and rank(s) of the officer(s) involved in the arrest of Ulysses Wilkerson on or about December 23, 2017;
- 8) Any and all dispatch communications and CAD logs in its entirety relating to the events leading to, following, and/or surrounding the arrest of Ulysses Wilkerson between December 23, 2017 at 11:00 PM and December 24, 2017 at 11:00 AM;
- 9) The organizational structure of Troy Police Department's Internal Affairs Division;
- 10) Troy Police Department's standard operating procedure for reporting, receiving, and investigating allegations of excessive force and police misconduct;
- 11) Any and all video and audio of statements made by witnesses (including the officer(s) involved) in the events surrounding the arrest of Ulysses Wilkerson;

Reason for Request: The requested documents will be made available to the general public, and this request is not being made for commercial purposes.

I also understand that if the City staff time is required to respond to my request; the first (1) hour is free and there will be a charge of Fifteen Dollars (\$15.00) per hour or portion thereof, per employee, thereafter.

Staff time responding to requests for public records which are not specifically identified or which by their volume, size or format require effort by employees to research, identify, copy and/or redact, or determining whether an exception applies, will be replied to as soon as reasonably practical. Provided, however, such efforts will be performed in a manner and at a time so as not to interfere with the normal operations of the City or the job duties of City employees.
