To Whom It May Concern:

Pursuant to the Idaho Public Records Act, I hereby request the following records:

Contracts and invoices related to the use of communication services at any and all county correctional or detention facility locations under the jurisdiction of this agency. This may encompass telecommunication, kiosk, and mobile tablet services.

Please provide the following relevant materials.

- Any and all open or active Requests for Proposal or similar solicitations regarding the provision, installation, maintenance, or use of communication services. If available or applicable, please also provide equivalent materials for video conferencing equipment and other electronic communication and telecommunication services.
- Any and all active contracts regarding the provision, installation, maintenance, financial requirements, associated commissions, or use of communication services. Please include all associated supplemental materials, including any and all attachments, amendments, and exhibits. Please provide any other materials regarding the terms of service, including the term and expiration date of the current contract, as well as any optional contract extensions. Please include the name of the current telecommunication provider, as well as the services currently being provided pursuant to the agreement. Relevant companies include, but are not limited to, CenturyLink, City Tele Coin, ICSolutions, JPay, and Securus Technologies.
- Any and all financial reports, commission reports, revenue reports, and invoices related to the provision, installation, maintenance, or use of communication services. Please include all usage and fee reports, providing as much segregable data as possible, including, but not limited to, the rate at which the funds were generated, the revenue generated for each service, the timeframe during which the funds were generated, the nature of the communication's payment (collect, prepaid, inmate account), etc. If available, please also provide equivalent materials for video conferencing equipment and other electronic communication and telecommunication services.

Please provide all current contract materials and invoices for the period January 1, 2015 through the date this request is processed.

If this office or agency does not hold arrestees or inmates under its jurisdiction, provision of the entity to whom such individuals are transferred would be greatly appreciated.

The requested documents will be made available to the general public, and this request is not being made for commercial purposes.

In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not.

Thank you in advance for your anticipated cooperation in this matter. I look forward to receiving your response to this request within 3 business days, as the statute requires.

Legacy Inmate Communications

Telephone System Agreement

This Agreement is made this the 12th day of February, 2013, by and between Legacy Inmate Communications a dba of Legacy Long Distance International, Inc. ("Legacy" or "the Company") with principal offices at 10833 Valley View Street - Suite 150, Cypress, CA 90630 and the Lewis County Sheriff's Office with principal offices located at 510 Oak Street, Nez Perce Idaho, 83543.

RECITALS

WHEREAS, the Company is in the business of providing various inmate communication services, operator assisted telecommunication services; and

WHEREAS, the Sheriff's Office operates and/or manages a correctional facility/detention center; and

WHEREAS, Legacy will install and maintain the Inmate Communication Operating System - ICON™. ICON™ is a complete turnkey Inmate Call Management System with investigative, technical, and administrative communication features; and

WHEREAS, Legacy will provide and maintain for the life of this Agreement inmate telephones and associated equipment described in the proposal sent by Legacy to the Lewis County Sheriff's Office for Inmate Telephone and Recording System to be installed at the Lewis County Jail located at 510 Oak Street, Nez Perce Idaho, 83543.

WHEREAS, The Sheriff's Office desires to enter into this Agreement in order to permit Inmates/Detainees the use of Company installed inmate telephones to place collect, collect pre-paid, and/or Debit calls; now

THEREFORE, in consideration of the premises and of the mutual covenants and agreements contained herein, the parties do hereby contract and agree as follows:

1. SERVICES PROVIDED BY LEGACY

1.1 Inmate Telephone Service

- (a) Collect Calls. To the extent consistent with applicable federal and state laws, rules and regulations, Legacy agrees to provide, and the Lewis County Sheriff's Office hereby agrees to accept the provision of operator services with automated assistance for the Lewis County Jail. Each operator service call originating from the telephones and placed through the Company may be charged "collect" to pre-approved destinations. Legacy will validate each call through the national Line Information Database (LIDB) and will only process "collect" calls to destination points that do not have registered blocks. Calls

shall only be billed upon "acceptance" by the destined party. Legacy shall notify each called destination that the call is coming from the Lewis County Jail, announce the name of the "caller/inmate", provide the called party with call rate information, and allow for acceptance or denial of the call. The Company will also provide the called party the option to block their telephone number from further calling from the Detention facilities.

- (b) Pre-Paid "Collect" Service. Legacy shall provide its Friends and Family pre-paid call service. Legacy agrees to provide pre-paid collect service as needed. The company will provide a toll-free access number for friends and family to call to set up prepaid "collect" service accounts. The Company shall also provide access to an internet-based website where prepaid services can be ordered.
- (c) Debit Card Service. Debit Cards will be provided to the Sheriff's Office as requested. Debit calling services can be utilized to call any destination worldwide. The Cards shall be construction paper based. The Sheriff's Office shall be invoiced for all Debit Cards requested. The Debit Cards will be discounted by the offered commission percentage. All Debit Card invoices shall be paid by the Sheriff's Office within thirty (30) days of the invoice date.
- (d) Free Call Service. The Company shall provide Inmate Free Call Service as designated by the Sheriff's Office.
- (e) Inmate Phones. The Company agrees to provide six (6) inmate phones and associated equipment for the entire period of this agreement. Additional phones will be added as needed and requested by the Lewis County Sheriff's Office.
- (f) Visitation Phones. Legacy agrees to provide Three (3) visitation phones to be located in the area designated by the Sheriff's Office.
- (g) Communications Management System (ICON™). The Company agrees to provide access to its inmate communications management system - ICON™. ICON™ shall provide all services described by the Company in its proposal to the Lewis County Sheriff's Office for Inmate Telephone and Recording Service at the detention facilities.
- (h) Service Level Responses. The Company agrees to provide the Sheriff's Office with twenty-four hour toll-free customer support, 365 days a year including holidays for the Inmate Telephone Service. The Company shall provide the following guaranteed Service Level Response times for Inmate Telephone Service:
 - Minor Service Category. A minor service category shall be defined as any service request the effects: one (1) individual inmate telephone not operational, static or other noise heard on the telephone line, ICON system administration action needed, new or customized report requested, or additional training requested. All minor category service requests shall be addressed within eight (8) hours of the report with problem resolution provided within twenty-four (24) hours.

- **Major Service Category.** A major service category shall be defined as any service request that effects; two (2) or more inmate telephones not operational, call detail/recording information not listing on the ICON System, call recording or live monitoring utilities not operational or dysfunctional. All major category service requests shall be addressed within four (4) hours of the report with problem resolution provided within four (4) hours of the report unless otherwise negotiated with the Sheriff's office.
- **Emergency Service Category.** A major service category shall be defined as any service request that reports twenty-five percent (25%) of inmate telephones being disabled in any location of the Detention Center. All major category service requests shall be addressed within one (1) hour and a service technician guaranteed on-site within two (2) hours of the report.

2. **COMPENSATION**

- 2.1 **Inmate Call Commissions.** The Company agrees to pay the Sheriff's Office a guaranteed percentage of all inmate telephone call revenues. The guaranteed commission percentage shall be fifty five (55%) percent.
- 2.2 **Inmate Call Commission Payment.** The Company shall remit all due commissions to the Sheriff's Office thirty (30) days after the end of each calendar month (EOM).
- 2.3 **Payment Calculation.** Gross billable revenue is calculated as the sum of minutes and charges. Commission due the Sheriff's Office shall be calculated as the product of the total gross billable revenue multiplied by the contracted percentage allowance.

3. **COMPLIANCE WITH LAW**

- 3.1 **Compliance with Law.** Legacy shall comply with all laws, rules and regulations affecting its obligations in conjunction with the provision of the including, without limitation, those relating to provision of information to End Users regarding operator services.

4. **TERMINATION AND CANCELLATION**

- 4.1 **Term.** This agreement shall commence on the date of installation of Legacy's services and shall continue in full force and effect for a period of five (5) years.
- 4.2 **Renewal Options.** Upon completion of the initial five (5) year term, Lewis County Sheriff's Office at its own discretion may continue to renew this agreement annually for an additional period of two (2) years. The Lewis County Sheriff's Office will provide Legacy with sixty (60) day notice of its intent to renew the Agreement. All terms and conditions shall remain in effect during the subsequent renewal periods.

5. MISCELLANEOUS

5.1 Governing Law. This Agreement shall be construed under and in accordance with the laws of the State of Idaho and shall be deemed performable in Lewis County.

5.2 Assignment. Notwithstanding the foregoing, neither the County nor Legacy may assign their rights and obligations under this Agreement without the prior written consent of the other, which consent shall not be unreasonably withheld.

5.3 Enforceability. The invalidity or enforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provisions hereof.

Notice. Notice shall be deemed to have been received upon receipt of a postage-prepaid letter or telephone facsimile transmission at the addresses set forth in the next sentence, unless otherwise changed by written notice from time to time. Notice to the Company shall be sent to Legacy Inmate Communications, 10833 Valley View Street - Suite 150, Cypress CA 90630. Attention: Contract Administrator, facsimile: 800-700-1116. Notice to the Lewis County Sheriff's Office shall be sent to: 510 Oak Street, Nez Perce Idaho, 83543.


5.4 Regulatory Requirements. This Agreement shall be construed in accordance with applicable state and federal laws, rules and regulations. In the event those regulatory or legal requirements are in any manner inconsistent with or require modification to the terms of this Agreement subsequent to the date of execution hereof, no written amendment or variation executed by both parties shall be necessary. Rather, any such amendment or variation shall be effective upon mailing of written notice by the Company via first-class, postage-prepaid mail or telephone facsimile transmission of written notice to the Sheriff's Office.

5.5 Confidentiality. Legacy and the County agree to hold confidential all information shared that may be marked or indicated by the other. The Sheriff's Office understands that Legacy's inmate communications operating system, iCON™, is proprietary and access to and all information about the system are to be considered confidential unless disclosure is required by state or federal law. Access to the system cannot be granted to any non-designated facility personnel. Should the County contract with a Vendor in the future to replace Legacy, the County will insure that the iCON™ system is not viewed or accessed by the Vendor.

5.6 Service Proposal for Inmate Telephone Service. It is agreed by both parties that Legacy's proposal to the Lewis County Sheriff's Office for Inmate Telephone and Recording Service shall serve as an addendum to this Agreement.


In Witness Hereof, the Company and the Lewis County Sheriff's Office have executed this Agreement on the 17th day of February, 2013. The individuals signing below warrant that they have the authority to sign for and on behalf of the respective parties.
