Dear Mr. Parker:

This letter serves as a determination concerning your request for records pursuant to the Freedom of Information Law ("FOIL") received by the District on February 17, 2022. You have requested copies of four (4) separate items, as contained in your enclosed FOIL request e-mail.

Please be advised that your requests are denied. Please find the individual reasons for such denial for each respective request enumerated below:

1. **Request**: "Any documents and communications regarding any steps the district took to verify the implementation of the recommendations, guidelines, best practices, procedures, mandates and/or requirements issued by the CDC, or NYS Health Department, or any other regulatory body, did not violate any of the following laws:

You will be advised in writing of the Superintendent's decision of your appeal within ten (10) business days following receipt of any written appeal. See N.Y. Pub. Off. Law §89(4)(a).
