A1 ARRIVED AND ENTERED INTO MY MOTEL ROOM. A1 AGREED TO GIVE ME A "BLOWJOB" , WHICH IS STREET SLANG FOR ORAL SEX. A1 ALSO AGREED TO HAVE SEXUAL INTERCOURSE WITH ME. A1 BROUGHT A CONDOM WITH HER TO MY ROOM. A1 AGREED TO DO THESE ACTS IN EXCHANGE FOR U.S CURRENCY.

I THEN GAVE THE TAKE DOWN SIGNAL AND A1 WAS TAKEN INTO CUSTODY.

A2 BROUGHT A1 TO THE MOTEL. A1 WAS IN POSSESSION OF MARIJUANA.
