To assess your request for a fee waiver, kindly furnish additional details on how the waiver from the Baltimore Police Department (BPD) would serve the public interest. Please elaborate on the following points:

1. Outline any potential public benefits arising from the disclosure of the requested records.

The routine use of riot control agents poses a threat to public safety as well as to the safety of LEOs. These chemicals are inherently dangerous and complete training is crucial. Insufficient or poorly explained safety data from manufacturers can pose unnecessary dangers to officers, civilians, and the environment.

2. Explain how the records could contribute to the understanding of matters under public scrutiny or controversy.

A wave of new research on the long-term effects of riot control agents has brought the issue to public attention. Recent papers highlight the chronic nature of the effects of smoke irritants on the human respiratory system¹ and the lasting psychological trauma of olfactory agent exposure². The publication of training materials may encourage departments to review safety policies.

3. Illustrate how the records would provide insight into the agency's fulfillment of its public duties.

The scientific understanding of riot control agents' effect on nearby life forms

has changed dramatically over just the past three years. In order to protect

civilians, officers, and the environment from undue harm, it is essential that LEOs
have a complete and up-to-date understanding of the materials in their care.

Transparency around riot control agents is a safety issue that touches all
involved in policing in any capacity. Manufacturers have an incentive to
downplay the dangers of their products and exaggerate their efficacy. By
sharing RCA materials, LEAs can help demand accountability from them.
