I left you a message -some follow up questions:

At annistown - are there enough emergency paper ballots for the day? Also - there are only 2 felt pens, so there is a very long wait and people are leaving. In addition, no ballots were cast for about the first 90 minutes, so the polls will have to remain open longer. People seem to be afraid to vote with paper ballots. Again, the county needs to send out a statement on tv/ radio if not social media to let people know that their votes will count.

1. Ballots were offered to voters in line, the voters chose to wait. The polling location did however not start offering Emergency Ballots until 7:25

At Harbins, one of the replacement formatting machines is not working. about 2/3 of the cards are being rejected. They need new formatting machines.

1. Verbally confirmed with Poll Manager and no additional issues since cards were replaced

Water Resources Poll manager would not give voter provisional. She was not on registration list. Voter said she is registered in Gwinnett. Told the Poll Watcher to talk with the manager and tell her that she has the right to a provisional ballot that will have to be cured.

1. Poll Manger indicated they have called Registration call center on any voters not appearing on the list and have been directed to either issue or not issues provisional. Advised PM if voter shows any indication they believe they are registered in Gwinnett to issue a provisional ballot regardless of response received from call center.


