INFORMATION

On April 16, 2018 at approximately 1453 hours, I was dispatched to 175 Wandering Trail in reference to the United States department of Homeland Security Secret Services (USSS) requesting assistance of the Jupiter Police Department to make contact with Mason Turner (W/M - 06/02/1997) at his residence. The secret service requested for the Jupiter Police Department to attempt to locate and detain Mason until they could arrive and interview him due to Mason making threats to the President of the United States.

Upon my arrival, Sgt. Counihan #374 and I made contact with Mason at the front door of the residence. Mason advised he wanted to place his two dogs in their cages before talking with us. Once Mason placed his dogs back in the residence he immediately closed the front door, locked it and refused to talk or open the door for law enforcement.

Masons' mother, Beverly Turner (W/F - 03/26/1956) was contacted via phone and she advised she was on her way to the residence. Beverly arrived on scene and gave permission for the Jupiter Police to enter the residence. I was able to make contact with Mason who was taking a shower in the bathroom. Mason exited the door of the bathroom and was placed into handcuffs, and placed into the rear of my patrol vehicle to be detained with no incident.

Secret Service agent Brian Deer #A05082 and Secret Service agent John Moreland #A12869 arrived at the residence to speak to Beverly and Mason regarding the threats made to the President of the United States.

Palm Beach Sheriff's Office Investigator M. Duplantis ID #4693 arrived on scene to speak to Mason and conducted a law enforcement on Mason (PBSO Case #18-063354). PBSO and the Secret Service agents transported Mason to Jerome Golden (1041 45th St, West Palm Beach, FL 33407) in which Agent Deer advised that they would interview Mason there. Agent Moreland also stated that he would email me their case number when it was available.

Body Worn Camera was utilized. This report was information only. There is no further information at this time.
