The Alabama Law Enforcement Agency has established the following procedure for requesting open (public) records.

- 1. Please complete and sign the attached form.
- 2. You may attach additional pages if necessary.
- 3. Please submit your request to:

- 4. TIPS:
 - A. Generally, only Alabama citizens or entities are entitled to open records.
 - B. The Freedom of Information Act (FOIA), 5 U.S.C.A. § 552, only covers "information maintained by executive branch agencies of the federal government."
 - C. Please avoid terms like "related to" or "pertaining to". These terms are vague and difficult to interpret precisely.
 - D. Accident reports sought under Section 32-10-7 of the Code of Alabama may be retrieved by visiting the ALEA.gov website. All other requests may only be obtained by court order or subpoena.
 - E. Traffic Homicide Investigations (THI) are criminal investigations that do not fall under the Open Records Law. A subpoena is required to obtain all THI reports which cannot be released until after the District Attorney's office has adjudicated prosecution. Once a subpoena is received, THI will contact The District Attorney's office for permission to release the report. Further questions can be addressed to <u>ALEA.THI@alea.gov</u>
 - F. Please write legibly or type your request.
 - G. Remember to sign your request.

We make every effort to answer requests within 30 days, which is the Attorney General's Office's suggested timeframe. Once your request is processed, you will receive a confirmation letter and additional instructions regarding payment, if required, or any deficiencies in your request.
