AMENDMENT 1**

This AMENDMENT is entered into by and between **Anoka County, Minnesota**, 2100 Third Avenue, Anoka, MN 55303 and **Morrison County, Minnesota**, 213 2st Ave. SE, Suite 1, Little Falls, MN 56345.

RECITALS:

- 1) The parties wish to amend their Contract C0007671, which is for Medical Examiner Services for the period from January 1, 2020 through December 31, 2020; and
- 2) Paragraph 13 in the contract requires a written agreement signed by the parties' authorized representative(s) to alter, modify or amend the contract.

THEREFORE, IT IS MUTUALLY AGREED:

1. The parties agree to amend Paragraph 1. TERM to read as follows:

1. TERM

1.1 This Contract will commence on January 1, 2020 and will terminate on December 31, 2020 unless it terminates by operation of circumstances outlined in Section 6. TERMINATION.

1.2 This Contract will automatically renew for two (2) two (2) year terms beginning January 1, 2021, unless either party provides notice of their intent not to renew at least ninety (90) days prior to the end of the current term.

2. The parties agree to amend Paragraph 6. TERMINATION to read as follows:

6.1.4 automatically without notice on December 31, 2024.

3. This amendment is part of, and will be annexed to, the parties' Contract #C0007671.
4. Other contract terms and conditions remain in full force and effect.

The proper parties having signed this amendment, the parties agree to be bound by its provisions.



WHEREAS, Dr. A. Quinn Strobl was appointed as Medical Examiner for Morrison County for a period January 1, 2021 through December 31, 2022.


