Hi,

There were two homelessness related items on the agenda back in 2014 & 2015. The one on 11/17/2014 was a presentation from the Marin Organizing Committee (the MOC) regarding funds for a year round emergency homeless shelter. The Council pledged support and set aside funds for the project. The [staff report](#) says the ask was for \$20,750.

I don't have past budgets in front of me, but I remember that we set aside some funds for this, I think in the City Council's budget, for when the project started and we would get the invoice. It never happened, and I think the MOC has since disbanded.

I remember discussing this topic when we did our budget revision last year when COVID first started.

I was not aware that there is some ongoing program we have been participating in. If so, the invoices have not been routed through my inbox.
