Mayor McEntee, Councilwoman Ossa, and Councilman Wickham,

In preparation for our call on Friday afternoon with Senator McGuire's Office, I wanted to let you know of a couple of things we are participating with at the Police Department regarding Homelessness:

On February 24th/25th, MVPD participated in the annual Point in Time (PIT) homeless count. MVPD documented 12 individuals (7 males, 5 unknown) within Mill Valley. Half of the vehicles were at locations on or adjacent to Miller Avenue, and the reaming half were scattered at different locations within city limits. Additionally, we are now participating with the County's CARES ACT Team, which Ashley McIntyre leads. I have worked closely with this group in the past. The team consists of various members from the County of Marin, San Rafael PD, Novato PD, and Sausalito PD. I recently introduced Lt. Lindsay Haynes to the group as a point of contact, and we now have Sgt. Ryan Smith as our liaison. We recently tapped into their resources to assist with one of our homeless individuals downtown (Lawrence). Although, he only participated for a couple of days and now is back in Mill Valley.

Please let me know if you have any questions. I am also providing you with Ashley's contact information. She is a fantastic partner.
