Hello Mr. Robinson,

Thank you for your recent email to Marin County Supervisor Kate Sears. Supervisor Sears forwarded your email to me for response, and I've copied Supervisor Sears on this email.

I want to start by clarifying that since the onset of the pandemic (March 13, 2020), the Richardson's Bay Regional Agency (RBRA) has removed 4 vessels from Richardson's Bay that sunk at anchor due to neglect, and one derelict vessel that was listing badly and would likely soon sink. All of these vessels were unoccupied and the sunken vessels were releasing debris and petrochemicals into the bay.

More broadly, I want to clarify that the RBRA has not forcibly removed any occupants from their vessels during the pandemic - or since I took on the role of Harbormaster in July of 2019.

I (and the RBRA Board of Directors) appreciate your passion for this issue. That's why in June of 2020, the Board adopted a Transition Plan that includes programs to support and encourage alternative housing options for vulnerable individuals who want to get off the water, and development of an eelgrass habitat management plan using a public outreach process that will explore how to best protect and enhance the Richardson's Bay ecosystems. The Transition Plan also sets clear expectations and timelines for vessels anchored in Richardson's Bay.
