This letter is in response to your Freedom of Information Act (FOIA) request to the Executive Office for Immigration Review (EOIR) dated July 9, 2018 in which you seek "e-mail messages from [Chief Immigration Judge] Mary Beth Keller using the words 'Pereira' or 'Notice to Appear' or 'Notices to Appear' from June 26-29, 2018."

Responsive documents are enclosed. Portions of the enclosed documents have been redacted in accordance with 5 U.S.C. § 552(b)(5) to protect certain intra-agency information protected by the deliberative process privilege.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
