REPORT SUMMARY

Bad Cob approached the entry control point (ECP) north of the camp, on foot and in the middle of the road. Officers made contact with Bad Cob at the ECP and asked if she needed police or medical assistance which she did not. Bad Cob had religious messages for officers. Bad Cob was told to leave the ECP and return to the camp, which she did.

Bad Cob returned to the ECP roughly ten minutes later with more religious messages for officers. I told Bad Cob to leave and return to the camp or she would be arrested for obstruction of a government function. The ECP's purpose is to provide security for the surrounding property and monitor north and south traffic on Highway 1806. Bad Cob's actions and refusal to leave, prevented officers from properly arrested. Bad Cob didn't move and continued to stare at me. I told her to walk back to camp or she would go to jail. Bad Cob began walking southbound towards the camp. Bad Cob walked roughly twenty feet before she turned around and returned to the ECP. Bad Cob was informed she was being placed under arrest for obstruction of a government function as she had been told at least three times by officers to leave the ECP.

Bad Cob was handcuffed (with flex cuffs), searched, and transported to the Morton County Jall by a Dunn County Deputy. Bad Cob refused to provide her name and date-of-birth to officers, claiming we should already know who she is. Another search was performed by the Dunn County Deputy prior to transport and he located two marijuana joints in Bad Cob's coat pocket. The marijuana was seized and placed into evidence.
