On 2/22/2017, Anton William Buekert was arrested for Obstruction of a Government Function and Resisting Arrest.

Throughout the day, LE had been monitoring protester activities at the Oceti Sakowin camp. The Army Corp had previously issued a 1400 hour deadline for protesters to remove themselves from camp, so the area could be thoroughly cleaned out.

At approximately 1400 hours LE moved south of the southern TCP and took a position along STHY 1806, next to the Oceti Sakowin camp. I was advised by command staff that through negotiations, several protesters wanted to be ceremoniously arrested. Several protesters approached LE on the highway and the field force was called to the front.

I approached with an arrest team, and the line began advancing on protesters. The protesters began moving away from the field force, however, they would not exit the area. Some protesters were arrested and as I advanced, I was approached by a male wearing black clothing, protective pads, and a helmet with face shield, later identified as Buekert.

I advised him that he was under arrest. He continued backing up, just out of arms reach. I reached out for him and he jumped back. I continued my advance, and reached out again, getting ahold of the front of his shirt.

The line broke and several officers ran passed us, while I was struggling with Buekert, other officers stopped to assist me in controlling Buekert. Buekert was actively resisting, struggling to maintain his posture, and keeping his hands in front of him. Buekert was taken to the ground, and with the help of other officers, we were able to get his hands behind his back and restrain them.

Buekert was advised that he was under arrest for obstructing a government function and resisting arrest at approximately 1615 hours. Buekert was assisted to his feet and escorted to the P&P van for identification and transport.
