5. Circumstances and/or other facts:

1.On 02/22/2017 I, Trooper Frank, was deployed at the Dakota Access Pipeline protests. I was a part of a mobile field force that consisted of multiple law enforcement agencies from different jurisdictions. I was assigned to an arrest team on the mobile field force. At approximately 1400, my field force had been deployed to Highway 1806, just west of the main protest camps on Army Corps of Engineers property.

- 2. The protesters located in the main camps had been given a mandatory evacuation order by Governor Burgum, as well as the Army Corps of Engineers. The camps had been notified of the eviction and it was highly publicized that all protester on Army Corps land where to leave by 1400, on 02/22/2017.
- 3.At approximately 1630, my mobile field force encountered approximately 60 resistant protesters on Highway 1806. An order was issued that they vacate the area otherwise they would be subject to arrest. Prior to that order, the protesters had also sent a liaison to negotiate with law enforcement. Their liaison had also been informed that anyone left in the camps or on the roadway, would be subject to arrest. My mobile field force moved on the resistant protesters and began to take them into custody.
- 4.I placed a female individual under arrest, on Highway 1806. I had held the female's right arm to escort her, and she fell to her knee. The female stated that she may have a broken foot. The foot was injured prior to my contact with her. I escorted the female back to Parole and Probation's booking area. The female was compliant and was handcuffed behind her back with zip handcuffs. I was assisted by Mandan Police Officer 222. Officer 222 conducted a search on the female. The female was then turned over to Parole and Probation for further processing. My name was tied to the arrest, and my picture was taken with female. I later identified the female as Teyana Lauri Viscarra (DOB: 06/11/1962, Possible CA OLN: N9970767). Morton County had provided Viscarra's name to me after the arrest.
