1. On February 23, 2017, the Morton County Sheriff's Department, along with other assisting law enforcement agencies went into the Oceti Sakowin protest camp and cleared that camp of individuals who had been living within the camp.
 2. Once the camp was secured, agents from the North Dakota Bureau of Criminal Investigation (NDBCI) went into the camp and documented the living conditions and general state of the camp with digital photographs.
