On 02/22/2017, I, Officer Schmeichel, was on duty as a special deputy in Morton County. I was assigned to be an arrest team member for one of the field force units.

It should be noted that at 1400 hours on 02/22/2017, the eviction for the Oceti Sakowin Camp was in effect. There were many individuals associated with the NoDAPL protests who had indicated they did not want to leave the camp area and would want to be arrested. Officers had also been advised that there was a group of people who wanted to be arrested around 1400 hours.

Officers waited on the north side of the south serpentine prior to 1400 hours. Around 1400 hours, we were assigned to respond to the area south of the serpentine. We were instructed to park our cars along the east side of Highway 1806 and be on stand-by.

Around 1600 hours, a group of people began approaching law enforcement. They were instructed to leave the area or be subject to arrest. Several of these individuals did not want to leave and were placed under arrest as the field force pushed them back.

During this time, as I was assigned to be an arrest member, I assisted in taking custody of three individuals. The first individual identified himself as Johnny Lee (01/03/1986). Johnny was handcuffed using flex-cuffs. His property was released to other officers who conducted the transport. Other officers also assisted with searching Johnny.

I also assisted in taking custody of Tonita Cervantes (09/29/1951). When I took custody of Tonita, she was not putting her hands behind her back. I gave her several instructions to "stop resisting" and "put your hands behind your back." Finally, Tonita began to cooperate. During this time, another officer assisted in applying a handcuff (flex-cuff) to her right hand. Once Tonita was cooperating and under control, I began to start a search. The transport officers arrived during this time and advised that they could take custody of Tonita and finish the search. They also advised that they could fix the flex-cuffs so they fit properly (the other officer had an issue with the flex-cuff). Tonita and her property were released to their custody.

The last individual I assisted with taking custody of was Jason Stuart Flores. Jason was taken into custody and flex-cuffs were applied. He was released to the transport officers who advised they could complete the search by the transport vans.

I assisted with various other officers as part of the arrest team.

I also completed affidavits for obstruction of a governmental function for all three individuals (Johnny Lee, Tonita Cervantes, and Jason Flores).

This ended my involvement.

On 02/22/2017, I, Officer Breid, was on duty as a special deputy in Morton County. I was informed that I would be part of an arrest team for the Fargo PD field unit.

At 1400 hours on 02/22/2017, an eviction for the Oceti Sakowin Camp was in effect issued by the Army Corps who are the property owners (federal government. There were many protesters who had informed they did not want to leave the camp area and would want to be arrested. Officers had also been advised that there was a group of people who wanted to be arrested around 1400 hours instead of leaving the camp on their own.

Officers waited on the north side of the south serpentine prior to 1400 hours. Around 1400 hours, we were assigned to respond to the area south of the serpentine. I parked my patrol car along with other officers on the east side of Highway 1806. We were informed to wait until we were needed.

Around 1600 hours, several people began approaching law enforcement. They were instructed to leave the area or be subject to arrest. Several of these individuals did not want to leave and started to line up across from Law Enforcement. Again the group was informed to leave or they would be arrested. After serveral times of being informed to leave the area law enforcement started to walk towards them.

While walking the crowd back, I took into custody a male identified as Eric Bivens (12/22/1986) for obstruction of a governmental function. I handcuffed Eric behind the back with zip-cuffs. I brought Eric over to a Parole & Probation where I conducted a search of his person. All of his items were placed into a bag and was given to P&P. I released Custody of Eric to P&P.

I helped other officers with the advancement and the retreat of Hwy 1806.
