Description of Infraction

On 02/03/2017 I, Correctional Officer Garrett Stepp, was working the day shift at the Morton County Correctional Center. I was informed of an inmate (Salas, Erick) who was refusing to give any information other than his name, therefore neither the staff nor I could fully book inmate Salas in, there was also no criminal history or information on this name when it was ran through dispatch in multiple states. I was also informed that there was bond money ready to be collected for inmate Salas. Without giving us his information and being fully booked the Correctional Center would be unable to release inmate Salas. Inmate Salas had also been in contact with an attorney (Sandra Freeman) multiple times on phone calls, as well as in secure visitation (face to face). Freeman told us multiple times each time she had contact with Salas that he would cooperate with us. Each time we attempted to book inmate Salas he would once again not cooperate. Eventually Freeman wanted to speak with a correctional officer after she met with Salas in secure visitation. I went up to talk with Freeman and she gave me a piece of paper with all of Salas's information on it (Name, DOB, SSN, Address, POB, ETC.). I informed Freeman that I appreciated her getting this information for me; however, we needed inmate Salas to tell us all of the information himself to make sure that it is all correct. Freeman said she understood and was just trying to help and that Salas should cooperate with us now. Upon review of the information that Freeman gave to me I realized the name she gave me on the paper was not the same that Salas had originally been giving us. Freeman told me his last name was Salas instead of Fierro, which is the last name inmate Salas was providing us with. I then had dispatch run a history for Erick Salas out of Texas (this is the state Freeman told me he was born in). I was able to get a criminal history as well as a driver's license abstract with a picture attached to confirm that this was the correct person. I then went to talk with inmate Salas and compare the picture in the abstract to him. It was in fact him and he told me his last name was Salas and that he would cooperate in booking. I then put all his new information in his file for when he would be booked in. There were other bookings and releases to be completed at this time and I informed inmate Salas that he would now have to wait to get booked in since he was uncooperative during the multiple attempts to book him in.

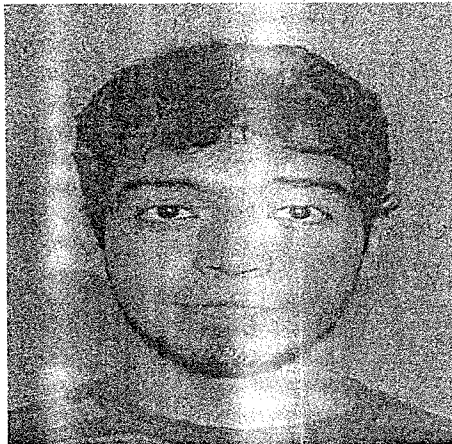
