- JUVENILE COURT ACT OF 1987. (705 ILCS 405/1)(WEST 2010):** Mandates that reports in which a minor was arrested, charged or investigated must be withheld in full. Reports in which minors are the victims of sex crimes or are incidentally mentioned are not exempt in full but names of minors may be redacted.
- PRIVATE INFORMATION. FOIA (5 ILCS 140/7 (1)(b) (West 2010):** "Private information" means unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, password or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home addresses and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person.
- INVASION OF PERSONAL PRIVACY. FOIA (5 ILCS 140/7(1)(c) (West 2010):** Allows a public body to withhold [p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwanted invasion of personal privacy, unless disclosure is consented in writing by the individual subjects of the information. The exemption defines "unwarranted invasion of personal privacy" as "the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information.
- PENDING LAW ENFORCEMENT PROCEEDINGS. FOIA (5 ILCS 140/7(1)(d)(i) (West 2010):** Allows a public body to withhold records that would interfere with pending or actually and reasonably contemplated law enforcement proceedings conducted by the law enforcement or correctional agency that received the FOIA request.
- DEPRIVATION OF FAIR TRIAL. FOIA (5 ILCS 140/7(1)(d)(iii) (West 2010):** Allows public body to withhold records when disclosure would create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing.
