Division of Election Law Enforcement New York State Board of Elections 4th Quarter 2022 Report

Complaints submitted to the Division of Election Law Enforcement assert various violations of the Election Law that vary in nature, content, complexity, and scope, which warrants that they are handled accordingly. Given these circumstances, each complaint has its own timeline for the investigation, determination, and action.
