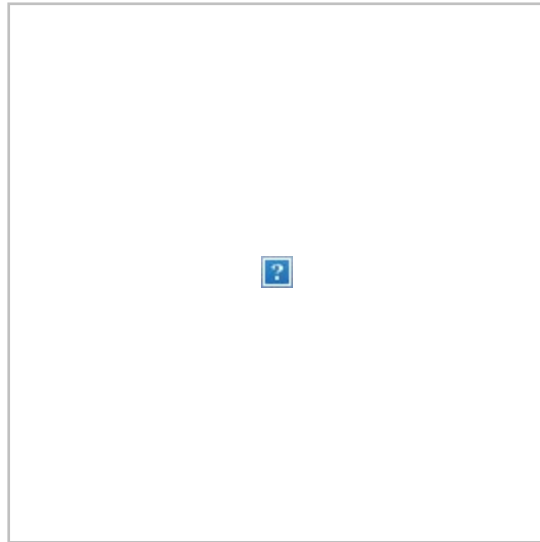

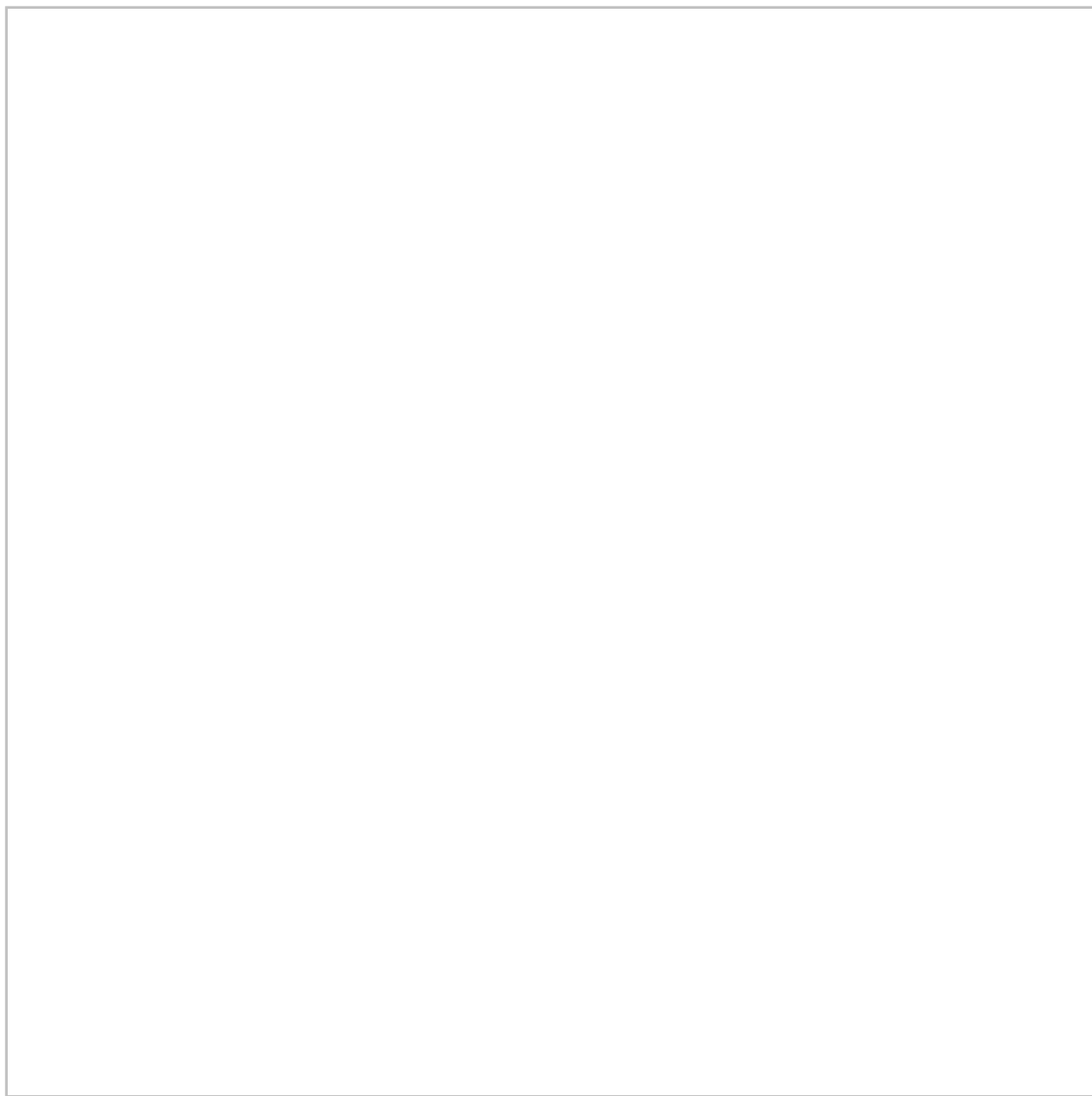
Hello!

The New York Council on Problem Gambling (NYCPG) is seeking applications for our phase 1, 2022 youth gambling prevention grant. The grant is available to

support New York State nonprofit agencies/organizations/associations who deliver services statewide and are interested in supporting our goal to building capacity to prevent youth gambling across NYS. This announcement is specifically for the 2022 phase 1 grant, but this grant is part of a 2-phase, 2-year project intended to:

1. Evaluate current policies, procedures, activities, awareness and interest of the statewide agency, and its affiliates, to prevent youth gambling (phase 1).
2. Plan and implement activities that will increase awareness, interest and/or readiness to prevent youth gambling on the statewide and affiliate levels (phase 2).

What is the eligibility criteria?

- Entities who are tax exempt.
- Entities based in New York State.
- Entities who deliver services statewide.
- Entities who have the capacity to carry out the grant requirements.

What are the requirements for phase 1?

- Conduct an organizational readiness assessment of current policies, procedures, activities, awareness, and interest to prevent youth gambling.
- All staff working on this project will complete the 4 required youth gambling prevention webinars offered by the NYCPG.

- Compile and evaluate readiness assessment data in preparation for strategic planning in project phase 2.

What funding will be awarded for phase 1?

Each contracted statewide agency will receive \$25,000.00.

What is the timeline?

Applications need to be submitted by September 16, 2022. A maximum of 4 applicants will be accepted. Project activities must be completed by December 30, 2022 and reports must be completed by December 30, 2022.

How do we apply?

Each agency will need to complete an application. Application details can be found in this project's RFA, linked in the button below.
