This is your "Notice-to-Proceed" to perform all of the work and furnish all labor, materials, equipment and transportation necessary for the Sanitary Sewer System Rehabilitation Program, Package 3, 5 and 6 for D and F-Rated Pipes and Manhole Rehabilitation Project for a not-to-exceed fee of Seven Million Six Hundred Twenty Four Thousand and Eight Hundred dollars (\$7,624,800) plus a sum of up to 15% for such contingencies as the City Manager, or his designee, deems appropriate.

The effective date of this Notice to Proceed is February 8, 2016. As stated in the Public Works Contract (Ag-5178), the work shall commence within fourteen (14) calendar days from the effective date of this Notice to Proceed, and shall be completed on or before the expiration of four hundred and fifty six (456) calendar days from the effective date of this Notice to Proceed.

We will forward the City Purchase Order to you once we receive it from our Accounting staff. The PO number shall be included on all invoices to the City for this project. PUBLIC WORKS CONTRACT (Formal Bid)

Sanitary Sewer System Rehabilitation Program, Package 3, 5, and 6 for D and F-Rated Pipes and Manhole Rehabilitation Project (33c1452s2)

THIS AGREEMENT, hereinafter referred to as the "Agreement", made and entered into this $\Delta \mu$ day of $\Delta \eta u \alpha \eta$ 201/2, by and between the CITY OF MONTEREY, a municipal corporation, hereinafter referred to as the "City", and K.J. WOODS CONSTRUCTION, INC. hereinafter referred to as the "Contractor";

<u>witnesseth:</u>

WHEREAS, the Council of the City has awarded a contract to the Contractor for performing the work hereinafter described in accordance with the City's Plans and Specifications and Contractor's sealed proposal;

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

- 1. SCOPE OF WORK. The Contractor shall perform all of the work and furnish all labor, materials, equipment and transportation necessary for Sanitary Sewer System Rehabilitation Program, Package 3, 5, and 6 for D and F-Rated Pipes and Manhole Rehabilitation. Work is to be as set out in the Plans and Specifications on file in the Office of the City Engineer and as in the Contractor's Proposal attached hereto, dated November 10, 2015, for the Total Base Bid (Items 1-112) in an amount not-to-exceed Seven Million Six Hundred Twenty Four Thousand and Eight Hundred dollars (\$7,624,800.00) plus a sum of up to 15% for such contingencies as the City Manager, or his designee, deems appropriate.
- 2. TIME OF PERFORMANCE. The work under this contract shall commence within fourteen (14) calendar days from the effective date of the Notice to Proceed and shall be completed on or before the expiration of Four Hundred and Fifty Six (456) calendar days from the effective date of the Notice to Proceed.
- If any provision in this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions will continue in full force without being impaired or invalidated in any way.
- 4. Contractor agrees that in the performance of this Agreement, it will comply with all applicable state, federal and local laws, codes and regulations. This Agreement shall be governed by and construed in accordance with the laws of the State of California and the City of Monterey.
- 5. In accordance with the provisions of Sections 1725.5, 1771.1, 1771.3, and 1771.4 of the Labor Code, this project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined by that chapter of the Labor Code, unless currently registered and qualified to perform public work pursuant to Section 1725.5 of the Labor Code. It is not a violation of this section for an unregistered contractor to submit a bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1735.5 at the time the contract is awarded.
- 6. The Monterey City Council awarded this contract on December 15, 2015 by Resolution 15-227 C.S.
- 7. This Agreement shall consist of this Public Works Contract document and the following items, all of which are on file in the office of the City Clerk and are incorporated herein and made a part hereof by reference:
 - A. Plans, Specifications, and Addenda
- E. Non-Collusion Declaration
- F. Debarment and Suspension Certification

- B. Accepted Proposal C. Performance Bond
- D. Payment Bond (labor and materials)
