This letter is to advise you of the California American Water (CAW) requirements for completion of the project now that plans are finalized and you are ready to begin construction.

PROJECT COSTS

As a California Public Utility Commission (CPUC) regulated company, CAW complies with the CPUC's Rule 16 for service installations.

Attached is an estimate of project costs developed by CAW. The cost estimate is developed for to establish a preliminary budget for inspection, taxes and other costs.

Prior to start of construction we require payment of \$ 7,072.00. Please refer to Attachment 1- Estimated Costs for more detail. This money is used to fund inspection, direct labor, overheads, and taxes for the next phase of the project as well as cover the costs already incurred on the project. These fees should be sent to California American Water, 4701 Beloit Drive, Sacramento, CA 95838, ATTN: Spencer Phillips.

CONSTRUCTION

Construction costs will be entirely born by you. To allow time to coordinate inspection scheduling, a pre-construction meeting must be held 3 days prior to the start of construction. To schedule a meeting, or obtain a Contractor Approval Application, please contact me at (916) 568-4210. **Please NOTE we CANNOT set water meters or provide service until the project is complete and accepted.**

At project completion we will determine the actual CAW costs and directly refund any overcharges to you. Conversely, if the actual costs exceed those collected, you will be required to pay the additional amount prior to project acceptance.
