I don't seem to have the NTP, but I found some interesting information, apparently we rejected all bids and went into negotiations with the low bidder, Smith Electric. They agreed to a price and quantity on 8/17/2009. Then, you have the contract that appears to be fully executed on October 22nd 2009. They had 90 days to complete the work, and it was accepted in February. So the NTP must have taken place soon after the contract execution.

CONTRACT

Interior and Exterior Lighting Retrofit at Monterey Conference Center

THIS AGREEMENT, made and entered into this and day of 2009, by and between the CITY OF MONTEREY, a municipal corporation, hereinafter referred as the "City", and Brannon Incorporated, dba Smith Electric Service hereinafter referred to as the "Contractor";

WITNESSETH:

WHEREAS, the Council of the City has awarded a contract to the Contractor for performing the work hereinafter mentioned in accordance with the sealed proposal of said Contractor;

NOW THEREFORE, IT IS AGREED AS FOLLOWS:

- SCOPE OF WORK. The Contractor shall perform all of the work and furnish all labor, materials, equipment and transportation necessary for Interior and Exterior Lighting Retrofit at Monterey Conference Center. Work is to be as set out in Plans and Specifications on file in the Office of the City Clerk and as in the negotiated contract therefore, in an amount not to exceed \$125,000 (one hundred twenty five thousand dollars) plus a sum up to 10% for such contingencies as the Deputy City Manager Plans and Public Works deems appropriate, 3rd day of June, 2009.
- TIME OF PERFORMANCE. The work under this contract shall commence within fourteen days after the issuance of the Notice to Proceed and shall be completed ninety (90) calendar days from the effective date of the Notice to Proceed.

Only the 1st page of the contract is on file in our office. Therefore I don't know if an NTP was issued and if so, what date, the length of any warranty, etc.
