Details on a Supplementary Report) Narrative not required if already covered in an Incident Report for Crime Against Person.</p> <p>On SAT 25 JUL 20 at approximately 2130 hours reporting officers LIER #2334 and RENGO #2321 were working a protest that turned unlawful. A group of about 100 people were protesting and walking in the middle of the streets obstructing traffic. Announcements were made over the loud speaker informing the group the protest had turned unlawful. CHRISTENSEN, Cole was among the group of protestors. Officers were able to block off the protestors to take them into custody. While officers were attempting to take an individual into custody that was resisting CHRISTENSEN approached the officers. Officers attempted to take CHRISTENSEN into custody. CHRISTENSEN pulled away from officers and ran from the North side of the street to the South side where he was eventually detained.</p>
