Details on a Supplementary Report) Narrative not required if already covered in an Incident Report for Crime Against Person.</p> <p>On SUN 26 JUL 20 at 0122 hours R/Os SAILORS #2382 and BYRD #2159 responded to Go Puff (101 N 40th St.) for a disturbance. Upon arrival R/Os met with Go Puff staff who stated that FLOOD, Connor W/M (01/25/1990) had attempted to assault a staff member. Multiple staff members advised that FLOOD had been at the location an hour prior to R/Os arrival causing a disturbance, and police responded. Police asked FLOOD to leave the area and he complied.</p> <p>FLOOD returned to the business prior to R/Os arrival. Multiple staff members advised that FLOOD entered the building and caused another disturbance. FLOOD attempted to swing at TRIZZA, Michael W/M (10/29/1996). TRIZZA advised that FLOOD had missed him and he did not have any injuries. R/Os observed FLOOD to be very intoxicated.</p> <p>When R/Os asked FLOOD what had happened tonight he advised "illegal activities". FLOOD stated he arrived at the business to purchase alcohol.</p> <p>FLOOD was transported to Douglas County Corrections and booked for misdemeanor assault third degree and refuse request to leave.</p> <p>Sgt. SCHEIDELER #2003 on scene.</p>
