On SAT 26JUL20 at approximately 2045 hours, Reporting Officers BAY # 2237 and BRAZIER # 2240 were conducting surveillance on a protest occurring at the intersection of Turner Boulevard and Farnam Streets. Information received via social media was the group of protestors (estimated at approximately 175) was going to commit violence. R/O BAY observed GUERRERO walking back and forth from a silver Kia Soul with Nebraska license plate VYB842. A registration check revealed the vehicle was registered to GUERRERO. It appeared GUERRERO was one of the main organizers of the protest. R/O's were in an undercover vehicle and observed the protestors walk eastbound on Farnam Street in the middle of the street; interfering with the flow of westbound traffic. R/O Ewin # 2333 observed GUERRERO, Crystal (W/F 08/29/1984) operating the above listed motor vehicle eastbound on Farnam Street, behind the protestors, violating the one-way traffic signs and interfering with the flow of traffic. The Omaha Police Department had to stop all vehicle traffic to protect the protestors.

At about 2055 hours, multiple announcements via cruiser PA were given to the crowd to disperse in the area of 24th Ave. and Farnam St. A few protesters left the area but about 150 protesters remained. Multiple announcements to disperse were given throughout the march as the protesters continued to the Douglas County Courthouse and through the Old Market. Officers attempted to block off traffic to the Old Market to ensure the safety of the protesters and they started throwing barricades at the cruisers trailing the march. At approximately 2137 hours, as the protesters moved Westbound on Farnam St. and 29th St. they were advised they were under arrest.
